2	<p><b>Election of the RASG-AFI Bureau</b></p> <p>Since the tenure of office of the current RASG-AFI Bureau will elapse after RASG-AFI/9 meeting, there is a need to elect the members of a new Bureau (comprising the Chairperson and three Vice-Chairpersons), who will steer the affairs of the Group until RASG-AFI/11 Meeting in 2025. As the officials of the Bureau are elected on rotational basis amongst States accredited to the ICAO ESAF and WACAF Regional Offices, the election of the new Bureau should be as follows:</p> <ul style="list-style-type: none"> <li>- Chairperson;</li> <li>- 1st Vice-Chairperson;</li> <li>- 2nd Vice-Chairperson (State);</li> <li>- 3rd Vice-Chairperson (Industry).</li> </ul>
