Session 1 *Benefits of Regional Cooperation*

Christopher Barks - Moderator

Regional Director, North American, Central American and Caribbean Regional Office,
ICAO

Mr. Christopher Barks is the Regional Director of ICAO's North American, Central American and Caribbean (NACC) Regional Office in Mexico City, where he leads efforts to enhance aviation safety, security, efficiency, and sustainability across 22 Member States and 19 overseas territories. He assumed the role in July 2023 after a distinguished career with the U.S. Federal Aviation Administration (FAA), including serving as Director of Global Strategy and Mission Support and Manager for ICAO and Global Affairs. He also led FAA activities in the Western Hemisphere and served as Senior Representative in Brussels and Northern Europe. Mr. Barks joined the FAA in 1997 and has extensive experience in international aviation policy and crisis response. He holds graduate and undergraduate degrees in international, European, and German studies, is fluent in Spanish, and is a Fellow of the Royal Aeronautical Society.



Lt. Col. (Ret'd) Egbert Field

Director General, Guyana Civil Aviation Authority

Lt. Col. (Ret'd) Egbert Field, A.A., is a distinguished Guyanese aviator, regulator and regional aviation leader with more than five decades of experience. He began flying at 18 and served 23 years in the Guyana Defence Force Air Corps, including as a fixed-wing commander, training and check pilot, and executive pilot to three Presidents.

With more than 18,000 flight hours, he is qualified on numerous aircraft, including the Boeing 757 and Airbus A320/321. He later served as Director of Flight Safety at the Jamaica Civil Aviation Authority and as a CASSOS transnational inspector. As Director General of the Guyana Civil Aviation Authority, he has championed stronger safety oversight, regulatory development, accident-investigation capability and regional cooperation. In 2026, he became the first Guyanese elected Chairman of CASSOS. He is also an ICAO Champion and recipient of Guyana's Golden Arrow of Achievement.



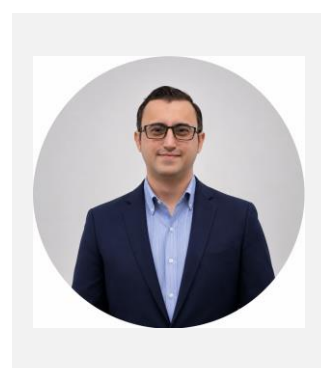


Elvin Lacayo

AIG Specialist, Regional Office for the Investigation of Aviation Accidents and Incidents

Mr. Elvin Lacayo works as an AIG Specialist at COCESNA/GRIAA. For the past nine years, he has been part of the team dedicated to the development of GRIAA, identifying solutions to strengthen regional cooperation among Member States in the application of Annex 13. Over the last five years, he has provided assistance to Central American States in establishing and implementing their accident investigation systems under the critical elements of AIG. He has participated in several ICAO USOAP CMA audits, supporting States in their preparation for these assessments.

Mr. Lacayo has also contributed to SSP establishment and has conducted evaluations for SMS acceptance within the industry. He holds a degree in Business Administration, along with postgraduate qualifications in Quality Management Systems (QMS) and Project Management. In addition, he holds a Private Pilot License and has successfully passed the theoretical examinations for the Commercial Pilot and Instrument Flight Rating at the Civil Aviation Authority.



Musayeroh Barrie

Director General, Sierra Leone Civil Aviation Authority (SLCAA), Sierra Leone

Madam Musayeroh Barrie is the Director General of the Sierra Leone Civil Aviation Authority (SLCAA), appointed in August 2023 as Sierra Leone's first female Director General of Civil Aviation and one of the youngest globally.

She holds a bachelor's degree in psychology, an MBA, a Diploma in Strategic Management and Leadership (CMI, UK), and is a Certified Aviation Security Professional Manager (AVSEC PM). Prior to her appointment, she served for over a decade as Country Director for Westminster, leading aviation security operations at Freetown International Airport.

Under her leadership, SLCAA achieved major milestones, including the approval of Sierra Leone's first Air Operator Certificate since 2008, reopening of the national aircraft registry, support for Air Sierra Leone's return, and establishment of the Consumer Protection Division. She is also a strong advocate for gender equality and youth empowerment.

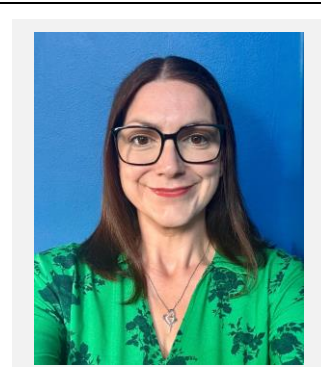


Fiona Hau

Serkan Simitcioglu - Moderator

Deputy Director, Monitoring, Oversight and Coordination (MOC), ICAO

Serkan Simitcioglu serves as Deputy Director, Monitoring, Oversight and Coordination in the Air Navigation Bureau at ICAO. Serkan is an aviation professional with extensive experience in international oversight systems, audit and monitoring programmes, regulatory engagement, and standards development in a multinational environment. In his current role, Serkan contributes to the management and evolution of ICAO's continuous monitoring and oversight activities, including the Universal Safety Oversight Audit Programme – Continuous Monitoring Approach and the RSOO/RAIO Assessment Programme (RRAP), and supports coordinated monitoring, analysis, and implementation support for States.

Prior to joining ICAO, Serkan spent more than fourteen years at the International Air Transport Association (IATA), where he held senior leadership roles in quality assurance, standards development, and audit oversight. From 2014 until early 2026, he served as Head of the IATA Operational Safety Audit (IOSA) Programme, leading its global operation and strategic evolution, overseeing airline registration, auditor management, regulatory engagement, and the strategic transformation of IOSA, including its transition to a risk-based oversight model and the insourcing of programme delivery.



Dawn Flanagan

Chief, Regional Safety Cooperation Unit (RSCU), ICAO

Ms. Dawn Flanagan is Chief of the Regional Safety Cooperation Unit in ICAO's Air Navigation Bureau, a position she assumed in late 2024. She brings nearly 30 years of experience in international civil aviation, dedicated to strengthening regional cooperation, enhancing institutional capacity, and supporting sustainable aviation development.

Ms. Flanagan began her career with the United States Federal Aviation Administration, where she managed technical assistance and aviation cooperation initiatives across the Caribbean and supported the establishment of regional safety oversight organizations. As an FAA Fellow seconded to ICAO's Technical Cooperation Bureau, she worked closely with donors, partners, and Member States to develop and implement programs that strengthened aviation safety, institutional effectiveness and regional collaboration. 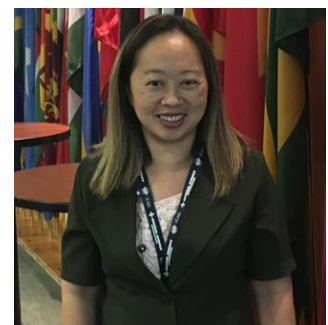

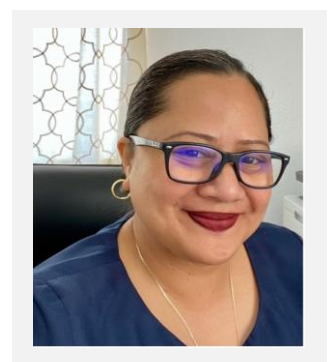
Dr. Vinolia Salesi

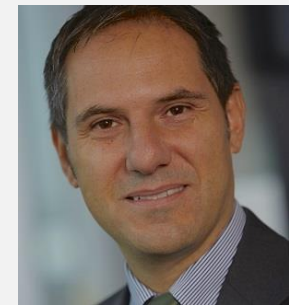
Lorenzo Pellegrini

Saheed Sulaman

Deputy Director General, Guyana Civil Aviation Authority

Dr Saheed Sulaman is Deputy Director General (Civil Aviation) at the Guyana Civil Aviation Authority (GCAA), where he oversees organisational development, administration, human resources, capacity building, and strategic initiatives. He brings 19 years of experience in Guyana's civil aviation sector, with a professional background spanning air transport management, economic regulation, policy development and aviation administration. 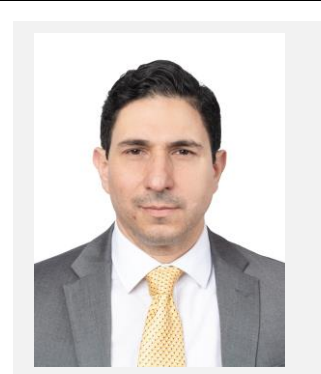
Luis Fernando Fiallos - Moderator

Regional Director, South American (SAM) Office, ICAO

Ecuadorian and Canadian aviation law expert who assumed the role of Regional Director of the ICAO SAM Office on 1 July 2026. Prior to this appointment, he served as Senior Legal Counsel at IATA in Montreal and Secretary of the Industry Litigation Working Group.

His career spans diplomacy, international aviation organizations, and aviation law practice. At Ecuador's Ministry of Foreign Affairs, he served as Permanent Representative to the Civil Aviation Council, leading bilateral air services negotiations with the United States, Canada, Qatar, and Malaysia. He also held diplomatic posts in Los Angeles, Ottawa, and Doha, and worked as a Legal Expert on an ICAO technical cooperation project in Angola.

Dr. Fiallos has advised Latin American airlines on regulatory compliance, commercial agreements, financing, and dispute resolution. He holds a Ph.D. in International Air Law from Leiden University and is the author of several publications.

Ronce Almond is Managing Director, Head of International Government Affairs, at American Airlines. He leads the airline's advocacy on policy and legal priorities in international affairs.

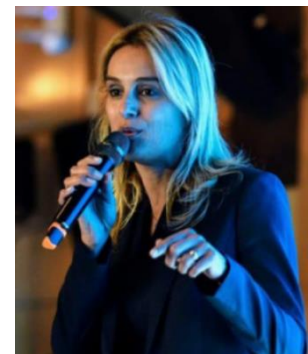

Anita Adjei Nmashie - Moderator

Representative of Ghana on the Council of ICAO

Ms. Anita Adjei-Nmashie is a distinguished Ghanaian aviation professional with over 35 years of extensive experience. She commenced her career in 1991 as the sole female Air Traffic Controller at the Ghana Civil Aviation Authority (GCAA) and subsequently became Ghana's first female Aviation Safety Inspector in 2000.
