EXPLANATORY NOTES ON THE AGENDA FOR APANPIRG/15

Agenda Item 1: **Review of Council and ANC action on APANPIRG/14 Report**

The Group will review the actions taken by the ANC and Council on the Conclusions of APANPIRG/14 and may take note and/or propose further action. The Group will also review the progress made on all the Decisions and Conclusions of APANPIRG/14.

Agenda Item 2: **ASIA/PAC Air Navigation system and Related Activities**

2.1 **ATM/AIS/SAR Matters**

The Group will review the report of the ATM/AIS/SAR SG/14 meeting and propose actions as required. The Group will also discuss other ATM/AIS/SAR matters, if any, raised by the Members, States and the Secretariat.

2.2 **CNS/MET Matters**

The Group will review the report of the CNS/MET SG/8 meeting and propose actions as required. The Group will also discuss other CNS/MET matters, if any, raised by the Members, States and the Secretariat.

2.3 **ATS Co-ordination Groups' Activities**

Under this item the Group will review the results of the ATS Co-ordination Groups/Co-ordination meetings in ASIA/PAC Regions and note the progress made so far.

2.4 **Other Air Navigation Matters**

Under this item the Group will consider matters related to the Air Navigation Plans, air navigation services and facilities in the regions. In accordance with its Terms of Reference, the Group is expected review the Statement of Basic Operational Requirements and Planning Criteria and recommend to the ANC any changes required in the light of new developments in the air navigation field. The Group will also review the report of the Asia and Pacific Area Traffic Forecasting Group.

Agenda Item 3: **CNS/ATM Implementation and Related Activities**

Under this item, the Group will review the report of the Future Direction Task Force and propose actions as may be required. The Group will also review CNS/ATM related activities in the Asia/Pacific Regions as well as other regions.
