Agenda Item 1 General Matters

A status report on valid CNS and ATM conclusions and decisions within the previous C/CAR WG, C/CAR DCA, E/CAR WG and E/CAR DCA Meetings will be given in this Agenda Item. A review of the air navigation deficiencies in the CAR region will be conducted during the Meeting. The Meeting also will analyze the ICAO and GREPECAS global, inter and intra-regional air navigation activities.

Agenda Item 2 ATM Developments

The Meeting will review the activities related to the ATM performance objectives of the Second Amendment of the *Global Plan* (Doc 9750) and the corresponding initiatives. The meeting will analyze new strategies for coordination of ATM activities implementation based on regional coordination requirements. The ATM Rapporteurs of the C/CAR and E/CAR Working Groups are also expected to inform the Meeting regarding the results of the work related to ATM implementation among the Caribbean and neighbouring States/Territories.

The Meeting will review regional implementations relating to airspace organization and management (AOM). The Meeting is expected to adopt initiatives to improve the airspace management and organization, ATS routes, RNAV, RNP, and the 5-letter name code (5LNC) assignment system in the CAR Region. The Meeting will focus on upper and lower airspace issues including planned ATM improvements in the Gulf of Mexico.

The Meeting will review activities related to Air Traffic Flow Management implementation (ATFM) in the CAR Region. The Meeting will formulate actions to improve demand and capacity balancing in air operations among the Caribbean and neighbouring States/Territories.

The Meeting will analyze programmes related to the implementation of Air Traffic Management (ATM) safety management and related programmes on safety assessment, incident investigation, the ICAO accident reporting system (ADREP), runway safety and aeronautical language proficiency requirements. The Meeting is expected to adopt initiatives to improve civil aviation safety in the CAR Region.

The Meeting will review progress made in the SAR Plans in the Caribbean. The Meeting is also expected to review the MCI ECAAMCIRP and the SAR Cooperation Agreements.

Agenda Item 3 CNS Developments

It is expected that Member States/Territories/International Organizations will provide to the Meeting information on the status of development of the MEVA II and E/CAR AFS Digital Networks, consequently, the Meeting will recommend actions to develop the networks and the interconnection/integration between them and with other regional networks.

The Meeting will discuss developments in air-ground communication including improvements to VHF and HF coverage and planning the introduction of data links in the CAR region. It will also discuss improvements to ground-ground communications through the migration to AMHS and any other related issues under this Agenda Item.

A review of the GNSS implementation in the Caribbean and other related matters will be discussed in the meeting.

The Meeting will review the Regional Surveillance Systems Plan (FASID Table CNS 4A), including the ADS-C and/or ADS-B implementation initiatives/plan in the CAR FIRs.

It also is expected that the Rapporteurs of the C/CAR and E/CAR Radar Data Sharing Task Forces will inform the Meeting regarding the results of work related to the implementation of radar data sharing among neighbouring ATS units.

The Meeting will also make a follow-up to the updated regional support to ICAO position for the ITU WRC-2007.

Agenda Item 4 Establishment of interfaces for ATM automated systems between adjacent ATS units

Based on Draft Conclusion ATM/5/9 / CNS/5/16 – *Agreements for ATM Automated Systems Interface* and Draft Conclusion ATM/5/10 / CNS/5/17 – *Establishment of an Action Plan for the interface of ATM Automated Systems*, both formulated by the GREPECAS Fifth ATM/CNS Subgroup Meeting, as well as the results of the other related agenda items of this Meeting, it is expected that the meeting will discuss the need to develop the technical infrastructure and will recommend actions in order to establish the interfaces for ATM automated systems between adjacent ATS units.

Agenda Item 5 Other Air Navigation Matters

The Meeting will discuss other air navigation issues related with the CAR States/Territories/International Organizations.
