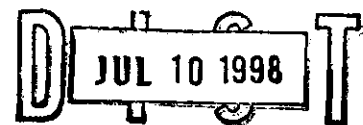

Agenda Item 5.1: **Reference of agenda items to the Executive Committee and Commissions and directives concerning co-ordination of action by those bodies**

SCHEDULE FOR CONSIDERATION OF AGENDA ITEMS

1. In order to facilitate co-ordination in the conduct of the business of the Assembly, a suggested schedule for consideration of agenda items has been prepared. The schedule is presented overleaf.
2. The numbers shown on the chart are those of the agenda items appearing in A32-WP/1 P/1. With respect to the Plenary meetings contemplated for Friday, 2 October to consider reports from the Executive Committee and Commissions as they become available, attention is called to A32-WP/15 P/6.
3. The letter "R" preceding an agenda item number on the schedule indicates approval of the report on that agenda item by the Executive Committee or Commissions. Changes in the schedule will also be required if the Assembly adds items to those appearing in A32-WP/1 P/1 or deletes some of them.
4. The Diplomatic Conference on the Authentic Chinese Text of the *Convention on International Civil Aviation* will open on Monday, 28 September at 1100 hours. It will be preceded by an informal meeting of Heads of Delegations of Contracting States at 1000 hours. The Committee on the Chinese Text of the Convention and amendments and on the draft Protocol on the Authentic Six-Language text of the *Convention on International Civil Aviation* will meet on Monday, 28 September at 1430 hours and the Commission of the Whole will meet on Thursday, 1 October at 0930 hours; the signing of the Protocol on the Authentic Six-Language Text of the *Convention on International Civil Aviation* (Chicago, 1944) and of the Final Act will take place on Thursday, 1 October at 1600 hours.
