4. Opening of the Meeting

The opening session of the Twenty Second Meeting of Directors of Civil Aviation of the Eastern Caribbean (E/CAR/DCA/22) will take place on Tuesday, 8 December 2009, at 09:00 hours in the Topaz Room of the Hyatt Regency Hotel, Trinidad.

5. Temperature

Trinidad and Tobago have two main seasons – the Dry Season, from January to May and the Wet or Rainy Season, from June to December. The islands share an average daytime temperature of 28°C that is warm but not unpleasantly humid and nights that are pleasantly cool.
