Twelfth Meeting of the Executive Committee

At its Twelfth Meeting, held on Thursday, 3 October 2019 at 1530 hours, the Executive Committee resumed consideration of its draft Reports to the Plenary on Agenda Item 16 (*Environmental Protection – International Aviation and Climate Change – Policy and Standardization*) (WP/574) and Agenda Item 17 [*Environmental Protection – Carbon Offsetting and Reduction Scheme for International Aviation (CORSIA)*] (WP/575), with the President of the Council providing an update on the status of consultations with the States concerned.

After further discussion, the Executive Committee reached consensus on the revised text of its Report on Agenda Item 16, which would be submitted to the Plenary for approval on Friday, 4 October 2019.

With regard to its Report on Agenda Item 17, it was agreed that following EX/12 China, the Russian Federation and India would jointly present to the Secretariat a paragraph describing their position, which would be posted on the A40 website under Reference Documents. Any Delegates wishing to express their views thereon were invited to meet with the said three States and the Secretariat in the Conference Room adjoining the Office of the President of the Council at 0800 hours on Friday, 4 October 2019, prior to the start of the Thirteenth Meeting at 0900 hours when the Committee would reconvene to finalize its draft Report on Agenda Item 17 for submission to the Plenary later that day.
