Yesterday's meetings, Tuesday, 1 October 2019

Ninth Meeting of the Executive Committee

At its Ninth Meeting, held on Tuesday, 1 October 2019 at 0900 hours, the Executive Committee resumed consideration of Agenda Item 26 (Other High-Level Policy Issues to be considered by the Executive Committee). It completed its consideration of Section 2 (Innovation) based on WP/14 presented by the Council and related papers, and agreed to recommend to the Plenary for adoption the new Assembly Resolution on innovation in aviation contained therein, as amended during the discussion. It then considered Section 3 (Regional Cooperation), Section 4 (Pandemics, Health Events and Aircraft Disinsection), and Section 5 (Other Papers), based on WP/5 presented by the Council and related papers. It was noted that the draft Assembly Resolution proposed in WP/5 had previously been addressed by the Committee under Agenda Item 14 (Facilitation Programmes).

The Executive Committee then reviewed the following draft Reports to the Plenary and took the actions indicated:

Fifth Meeting of the Technical Commission

At its fifth and final meeting on Tuesday, 1 October 2019, at 0900 hours, the Technical Commission completed its review of draft reports and approved report materials on Agenda Items 27 (Annual Reports of the Council to the Assembly for 2016, 2017 and 2018), Agenda Item 28 (Aviation Safety and Air Navigation Policy), Agenda Item 29 (Aviation Safety and Air Navigation Regional Implementation Coordination Mechanisms) and Agenda Item 30 (Other issues to be considered by the Technical Commission).

Fifth Plenary Meeting

At the Fifth Plenary Meeting, held on Tuesday, 1 October 2019, at 1420 hours, Part 3 of the election of the Council was conducted under Agenda Item 5 in the presence of a representative of the audit consultancy firm BDO Jordan. With 177 States voting and 177 votes cast, the number of votes required for election in Part 3 was at least 89. There were 14 candidates for 13 seats in this Part, and 13 were elected on the first electronic ballot as follows: Costa Rica, Côte d'Ivoire, the Dominican Republic, Equatorial Guinea, Greece, Malaysia, Paraguay, Peru, the Republic of Korea, Sudan, Tunisia, the United Arab Emirates and Zambia. It was highlighted that it was the first time in the 75-year history of ICAO that Côte d'Ivoire, Equatorial Guinea, Greece, Sudan and Zambia had been elected to the Council.

Under Agenda Item 9, the Plenary then reviewed, and approved without any changes, the General Section of the Legal Commission's Report and the Legal Commission's Report on Agenda Items 37 (Annual Reports of the Council to the Assembly for 2016, 2017 and 2018), 38 (Work Programme of the Organization in the legal field), 39 (Consolidated statement of continuing ICAO policies in the legal field) and 40 (Other issues to be considered by the Legal Commission) as contained in WP/617. In addition, the Plenary adopted Resolution 39/1 as presented in that paper.

Review of WP/604 containing the General Section of the Administrative Commission's Report and the Administrative Commission's Report on Agenda Items 41 to 52 was deferred to the Plenary's next meeting.

The remainder of the meeting was devoted to Agenda Item 8, with general statements being delivered by the Delegations of: Sierra Leone, New Zealand, the Maldives, Saint Lucia, Morocco, the United Republic of Tanzania, Pakistan, Eritrea, South Sudan and Guyana. Brief interventions were also made by the Delegations of Japan and China.
