Juan Carlos Salazar

Secretary General
International Civil Aviation Organization (ICAO)

Mr. Juan Carlos Salazar is the Secretary General of the International Civil Aviation Organization (ICAO). He was first appointed for a three-year term starting August 2021. On 11 March 2024, the ICAO Council renewed his appointment for a second consecutive three-year term, to begin August 2024. His career in international civil aviation spans over 30 years in various advisory and leadership roles. Prior to his appointment as Secretary General, Mr. Salazar served as Director General of Aeronautica Civil of Colombia – Aerocivil. For the twelve years prior to joining Aerocivil, Mr. Salazar was a Senior Advisor to the UAE General Civil Aviation Authority.

His professional experience also includes terms as the President of Latin American Civil Aviation Commission (LACAC), Secretary of the Colombian Civil Aviation Board and Director of its Air Transport Office, Director General of Air Transport at the Colombian Ministry of Transport, Corporate Secretary and Director of the Legal Department of Tampa Cargo (currently known as Avianca Cargo). Mr. Salazar is a lawyer and has earned advanced degrees from Harvard University (Master in Public Administration - MPA) and McGill University (Master in Air and Space Law - LLM), and was awarded an Honorary Doctorate degree in Law from Korea Aerospace University. He is fluent in Spanish, English and French, and speaks basic Arabic.

From 2007-2013, he was Senior Legal Counsel in IATA, supporting its external affairs portfolio. Before joining IATA, Michael was an aviation lawyer in private practice in London and Paris.

He holds law degrees from King's College, London and the Sorbonne University in Paris, as well as a Master's degree from the University of Edinburgh. He is admitted as a Solicitor in England & Wales and as an Avocat in France.

Michael is a Fellow of the Royal Aeronautical Society and former Chairman of its Air Law Group and a Committee member of the European Air Law Association. He has been a contributing editor of Shawcross & Beaumont on Air Law since 2011.

Emerging Litigation Trends in Aviation and Impacts on International Air Law Treaties

Georges Leloudas

Professor

Institute of International Shipping and Trade Law, Swansea University


Professor Leloudas joined the Institute of International Shipping and Trade Law (IISTL) in 2011 as a lecturer and was promoted to senior lecturer in 2014, then to Associate Professor in 2018, and to Professor in 2022. He graduated from the National and Kapodistrian University of Athens and holds LLM degrees in Commercial Law from the University of Bristol and in Air and Space Law from McGill University's Institute of Air and Space Law. He completed his PhD in air law, focusing on liability and insurance, at Trinity Hall, Cambridge University, in 2009. George previously worked as a Solicitor at Gates and Partners in London for several years, advising on aerospace liability and airlines' regulatory issues. He also served as an assistant to the legal counsel of the International Union of Aviation Insurers (IUAI), supporting the replacement of the Rome Convention on Surface Damage. He is an instructor at training centres of the International Air Transport Association (IATA) and the International Civil Aviation Organisation (ICAO), where he teaches aviation insurance law and air cargo liability.

George's principal research interest is air carriage and air law (broadly defined), but his research and teaching interests also extend to multimodal transport, insurance law, arbitration, and the regulation of autonomous transport systems. He has published two monographs: the first on Risk and Liability in Air Law and the second on Air Cargo Insurance, co-authored with Professor Malcolm Clarke of Cambridge University, along with a substantial number of peer-reviewed articles and book chapters, the most recent one on "Unmanned Aircraft Systems and Strict Product Liability in the UK: Time for Reform" (2026) 51(1) ASL 1-30 (with Furkan Bulut). He is also the General Editor of the leading air law publication, Shawcross and Beaumont on Air Law (LexisNexis), and his most recent book on the Montreal Convention 1999 (Elgar Publishing), published with Professor Paul Dempsey, Dr Laurent Chassot, and 34 internationally renowned experts, offers a detailed, article-by-article analysis of the Montreal Convention 1999. His work was most recently cited by the English High Court in *SMT Global Logistics Limited v Georgian Airlines Llc* [2025] EWHC 739 (Comm) and the New South Wales Court of Appeal in *Air Canada v Evans* [2024] NSWCA 153.

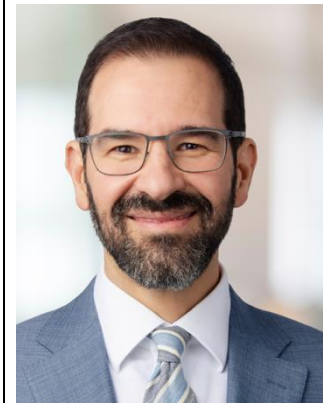

In this role, he is responsible for the strategic direction of the IIASL, its research agenda, and its international academic and professional engagement. He also oversees Leiden University's award-winning Advanced Master of Laws (LL.M.) in Air and Space Law programme, supporting its academic coordination and continued international standing. Steven holds a part-time professorship at the European University Institute (EUI) Florence School of Regulation (FSR Transport), through which he regularly engages in policy dialogue with the European Commission, national supervisory authorities, and industry stakeholders. His academic research focuses on the economic and environmental regulation of aviation, as well as air transport competition law. Drawing on his interdisciplinary background in economics and law, his work integrates legal analysis with economic and policy perspectives. Steven is a Fellow of the Royal Aeronautical Society. Currently based in Barbados, she continues to work in her specialist field of aviation and has also been appointed to the Boards of key aviation agencies including the Civil Aviation Authority.



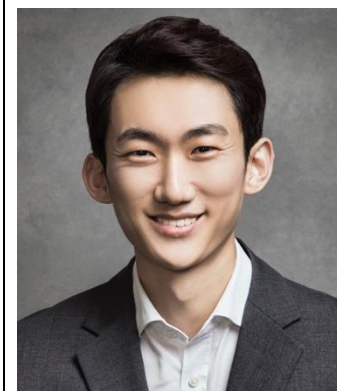

David Dueñas is a lawyer and holds a Master's degree in Public Law, graduating with highest honors from the University of Chile. He has over 35 years of experience in the civil aviation sector, having served as legal advisor at the Chilean Civil Aviation Authority (DGCA) and Head of the National Aircraft Registry of Chile. Since 2015, he has been the Head of the Legal Department of the Civil Aeronautics Board (CAB), the authority responsible for administering Chile's commercial air policy.

He currently serves as Acting Secretary General of the CAB. He has been appointed as Chile's Alternate Representative to the ICAO Council for two terms and is currently the Vice Chairperson of the ICAO Air Transport Regulation Panel (ATRP). He has also provided legal consulting services to ICAO and the UNDP as a legal expert on technical cooperation projects in several countries.

He is currently a professor at Santa María University in Santiago and has extensive experience in teaching Air Law for Latin American countries and Spain. He is a member of the Ibero-American Institute of Air and Space Law, of the Latin American Association of Air and Space Law, and Director of the Chilean Institute of Air and Space Law.

Until February 2026, Dr Aleck served for over 20 years as Executive Manager of CASA's Legal, International and Regulatory Affairs division, with responsibility for the Authority's advisory, litigation, enforcement, investigative, drafting and other legally related functions.

Dr Aleck joined what was then the Civil Aviation Authority in 1993 as a Legal Officer, assuming the role of CASA's Senior Legal Counsel in 1995 and Chief Legal Officer in 1996. During his tenure at CASA, he has held a number of senior executive positions in the legal, operational and policy fields.

Dr Aleck serves as chair of the ICAO Task Force on Article 12 (Rules of the Air), the Safety Information Protection Task Force and the Safety Information Protection Implementation Group. He is a member of the ICAO Study Group on Legal Issues Related to Pilotless Aircraft.

From September 1998 to August 2003, Dr Aleck was Australia's representative on the Council of the International Civil Aviation Organization (ICAO). He has represented Australia at a number of international aviation meetings and conferences, including most recently the 42nd Session of the ICAO Assembly in 2025 and the 39th Session of the ICAO Legal Committee in 2024. Dr Aleck chaired the Legal Commission at the 41st Session of the ICAO Assembly in 2022. He has actively participated in every Civil Aviation Legal Advisers Forum.

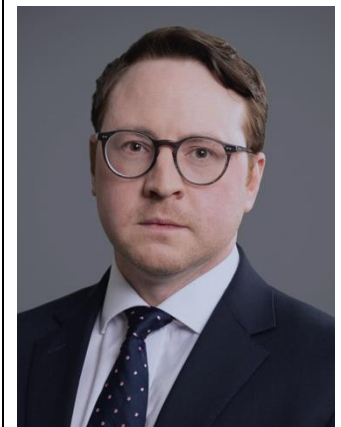

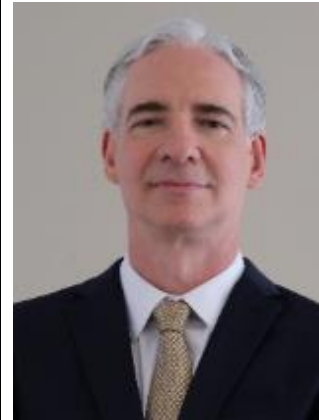
