





### Salvatore Sciacchitano

President of the Council, International Civil Aviation Organization (ICAO)

Mr. Salvatore Sciacchitano is the sixth President of the ICAO Council. He succeeded Dr. Olumuyiwa Benard Aliu on 1 January 2020.

Mr Sciacchitano graduated in Telecommunications Engineering from the University of Catania and began his career in aviation in 1980, joining the Italian Airworthiness Authority (RAI) where he held positions of increasing responsibility, serving as the organization's Regulation Director in 1992, then as Technical Director and, in 1996, as Director General.

With the merger of the aviation branch of the Ministry of Transport and RAI and the subsequent establishment of the Italian Civil Aviation Authority (ENAC), Mr. Sciacchitano assumed the position of Deputy Director General. In this position, he played an instrumental role in coordinating the core business divisions of the newly founded structure. He was also entrusted with multiple international mandates, chairing the Permanent Commission of EUROCONTROL, representing Italy in the Management Board of European Aviation Safety Agency (EASA), holding the Vice-Presidency of the EUROCONTROL Provisional Council and coordinating the Italian delegation during ICAO Assemblies.

As a result of his extensive experience in aviation international affairs, Mr. Sciacchitano was appointed Executive Secretary of the European Civil Aviation Conference (ECAC) in 2010. In February 2019, he joined the Italian Delegation on the Council of ICAO, where he served until assuming his duties as President of the Council.




### **Juan Carlos Salazar**

Secretary General, International Civil Aviation Organization (ICAO)

Mr. Juan Carlos Salazar is the Secretary General of the International Civil Aviation Organization (ICAO). He was first appointed for a three-year term starting August 2021. On 11 March 2024, the ICAO Council renewed his appointment for a second consecutive three-year term, which began in August 2024. His career in international civil aviation spans over 27 years in various advisory and leadership roles. Prior to his appointment as Secretary General, Mr. Salazar served as Director General of Aeronautica Civil of Colombia -Aerocivil. For the twelve years before joining Aerocivil, Mr. Salazar was a Senior Advisor to the UAE General Civil Aviation Authority. His professional experience also includes terms as the President of Latin American Civil Aviation Commission (LACAC), Secretary of the Colombian Civil Aviation Board and Director of its Air Transport Office, Director General of Air Transport at the Colombian Ministry of Transport, Corporate Secretary and Director of the Legal Department of Tampa Cargo (currently known as Avianca Cargo). Mr. Salazar is a lawyer and has earned advanced degrees from Harvard University (master's in public administration - MPA) and McGill University (Master in Air and Space Law - LLM). He is fluent in Spanish, English and French, and speaks basic Arabic.

### **Erick Ferrandez**

EASA Representative to ICAO and Canada

Erick Ferrandez is an aeronautical engineer who spent 14 years in the aviation industry, specialising in Flight Operations, before joining the European Union Aviation Safety Agency (EASA). He gained operational experience from both the manufacturer and airline perspectives — working with the Airbus Flight Operations Division and in the Operational Control Centre of US Airways in the United States. Erick joined EASA in 2006. For eight years, he led the development and management of EASA's International Technical Cooperation programmes. He then served as Head of the Safety Intelligence and Performance Department, overseeing the production of the Annual Safety Review (ASR), the EASA Safety Risk Portfolios, and the analysis of security and cybersecurity risks impacting aviation safety. His responsibilities also included coordination of EASA's involvement in safety investigations and leading the Agency's Safety Promotion activities.

From 2017 to 2022, he also served as Programme Manager for Data4Safety, the European Big Data initiative for aviation safety, during its initial design and development phase. Since January 2023, Erick has been based in Montréal as EASA's Permanent Representative to ICAO and Canada.







### **Kabbs Twijuke**

Representative of Uganda to ICAO and Chair of the ANC ad hoc Working Group on Innovation

Mr. Twijuke is a Commissioner of the Air Navigation Commission (ANC) nominated by Uganda in 2016 and has since 2008 served as the Representative of Uganda to International Civil Aviation Organisation (ICAO). Prior to joining ANC, he served as a member of the Council of ICAO from 2008 to 2013. His aviation career began in 1979 when he joined the national carrier as a Planning Engineer Trainee. After intensive professional training, he became Planning and Aircraft Maintenance Engineer in 1982 and was subsequently appointed to Head of Engineering and Maintenance Section in 1986. His responsibilities included developing and implementation of engineering policies and procedures and continuing airworthiness in a costeffective manner. In 1990 he was appointed the Manager for Engineering Development and Planning with the mandate of ensuring that the Airline effectively complied with all regulatory requirements. In 1991, he joined the Uganda CAA as Director of Air Transport. His responsibilities included strategic planning, licensing air operators, advising Government on matters of bilateral and multilateral air services agreements and ratification of international aviation instruments. In 2004, he was appointed the Director for Safety and Security oversight as well as Economic Regulations. He was responsible for among others, formulation and enforcement of national civil aviation regulations, licensing of technical personnel and aviation service providers. Having actively served as a Member of the Air Navigation Commission, Representative of Uganda on ICAO Council and Director of UCAA responsible for the oversight of safety, security and economic regulations, he has an extensive knowledge and experience in the development, adoption and implementation of ICAO Standards and other provisions. Mr. Twijuke holds an honors Bachelor of Science Degree in Mechanical Engineering from Makerere University, Kampala, and a Master of Science Degree in Air Transport Engineering from Cranfield Institute of Technology, UK. He is a Fellow of the Prestigious Hubert Humphrey Fellowship Program, USA (FAA and American University) and a Fellow of the Royal Aeronautical Society, UK.

### **High Level discussion on Innovation in Aviation**

### Christian Schleifer-Heingärtner

Council Representative of Austria and the ABIS group at ICAO



Christian started his aviation career 36 years ago as Avionics Maintenance Engineer and currently is the Representative of Austria and the Abis Group on the Council of the International Civil Aviation Organization (ICAO). Next to his role as Council member, he was appointed as chair of the ICAO Group on Innovation as well as the Industry Consultative Forum responsible for the collaboration with the industry on strategy inputs. He also got elected to chair the ICAO Committee on Joint Support of Air Navigation Services (JSC). Between 2014 and 2022 Christian Schleifer served as the Director General and CEO of EUROCAE, a leading international Standard Developing Organisation (SDO), specialised in high quality and safety critical standards, based in Paris/France. In this role he was responsible for the operational management, development, restructuring and growth of EUROCAE. From 2009 until 2013 Christian was appointed as Air Navigation Commissioner (ANC) at ICAO. During 2012 and 2013 as President of the Air Navigation Commission, he was responsible for developing Standards and Recommended Practices (SARPs) in the field of Air Navigation and Safety. ### **Poppy Khoza**

Director of Civil Aviation, South African Civil Aviation Authority – and President of A41

Ms. Poppy Khoza is the Director of Civil Aviation (DG) at the South African Civil Aviation Authority (SACAA), having been re-appointed by the South African Government for a third successive five-year term starting on 1 December 2023. Throughout her tenure, Ms. Khoza has demonstrated exceptional leadership, chairing two significant ICAO panels—the Aviation Security Panel and the High-Level Conference on the COVID-19 pandemic. In 2022, she made history by becoming the first woman to preside over the ICAO General Assembly since the organization's inception in 1944. Her trailblazing work has earned her numerous accolades, including the 2023 IATA Inspirational Role Model Award — Diversity and Inclusion Awards, the Aviation Sector and Regional Leader Award, Best Chief Executive Officer Awards, Top Empowered Business Leader, Public Service Leader of the Year, and recognition as South Africa's Most Influential Woman in Business and Government within Agencies and Regulatory Authorities.

Ms. Khoza was also the inaugural recipient of the Flight Safety Foundation's Gloria Heath Award, which celebrates notable female achievements in civil aviation and her leadership in promoting gender diversity within the industry. Her contributions to the development of aviation in Africa have been recognized by the African Civil Aviation Commission (AFCAC) and the AFI group. A passionate advocate for gender equality in aviation globally, Ms. Khoza has led the transformation of the SACAA, which now consists of 51% female employees and boasts 50% women in Executive Management roles. She played a pivotal role in conceptualizing and implementing the first-ever Global Aviation Gender Summit, held in August 2018 in South Africa, in collaboration with ICAO, UNESCO, and UN Women.

Under Ms. Khoza's stewardship, the SACAA has received the Best Performing Institution in Transport Award on four occasions and has achieved eleven clean audits over 12 financial years from the Auditor-General of South Africa, reflecting strong corporate governance. Her visionary leadership continues to position the SACAA as a benchmark for excellence in the aviation industry, both in South Africa and globally.



Environment and Sustainability Marketing Manager, Airbus




