EXECUTIVE SUMMARY

In order to facilitate coordination in the conduct of the business of the Assembly, a suggested schedule for consideration of agenda items has been prepared. The schedule is presented overleaf.

The numbers shown on the chart are those of the agenda items appearing in A42-WP/1. With respect to the Plenary meetings contemplated for Thursday and Friday, 2 and 3 October 2025, these will consider reports from the Executive Committee and Commissions as they become available.

The letter “R” preceding an agenda item number on the schedule indicates approval of the report on that agenda item by the Executive Committee or Commissions. Changes in the schedule will also be required if the Assembly adds or deletes items to those appearing in A42-WP/1.

The First Meeting of the Plenary on 23 September 2025 will start promptly at 1000 hours. Members of Delegations should ensure that they are seated in the Assembly Hall by no later than 0930 hours.

Ordinarily the working hours of the Assembly will be from 0900 to 1200 hours and from 1400 to 1700 hours. Any variation to these hours will be notified accordingly in advance.
