Secretariat

Context

- Plenary postponed to 2026 (Letter E.OSG-NACC116218, 12 June 2025)
- Two-phase format, as used in RASG-PA/13 and RASG-PA/14:
 1. Virtual/Asynchronous Phase
 2. In-Person Phase

Key Dates

- Participant Registration Deadline: 17 October 2025
- Document Submission: 17 November 2025 – 9 January 2026
- Virtual/Asynchronous Phase: 19 January – 12 February 2026
- In-Person Meeting: 2 – 6 March 2026, Mexico City

The Asynchronous Phase

- Working and Information Papers posted on RASG-PA website and MS Teams
- States and Organizations review and submit comments from 19 Jan to 12 Feb 2026
- Secretariat consolidates all contributions into a revised package

Deadlines in Detail

- 17 Oct 2025: Registration deadline
- 17 Nov 2025 – 9 Jan 2026: Submission of Working and Information Papers
- 19 Jan – 12 Feb 2026: Asynchronous review and commenting
- 2 – 6 Mar 2026: In-person deliberations and adoption of Conclusions/Decisions

In-Person Phase

- Short, focused deliberations based on consolidated comments
- Formal adoption of Conclusions and Decisions
- Includes the Joint RASG-PA/GREPECAS Session

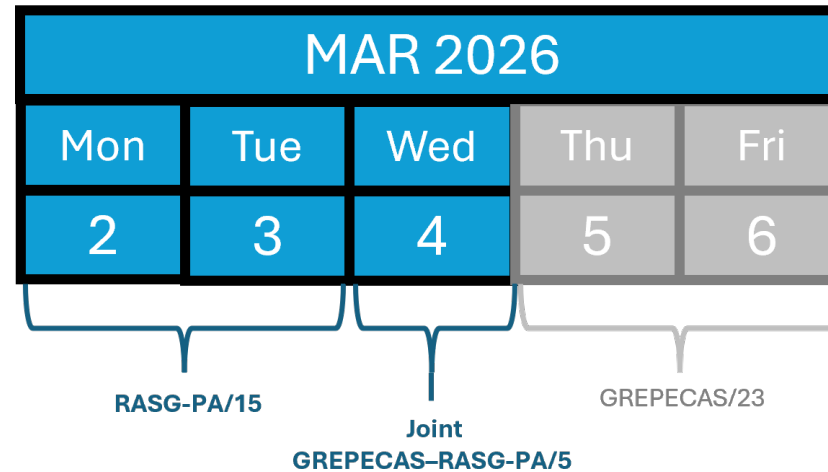
Roles and Responsibilities

- Secretariat: manages publication, comments, and consolidation
- States and Organizations: ensure active and timely contributions
- Chairs: guide discussions and confirm outcomes during in-person phase

PA-RAST Preparatory Actions for RASG-PA/15

- Define agenda contributions aligned with TORs (data-driven analysis, HRC projects, safety targets)
- Identify Working Papers to be developed (e.g. status of projects, proposed Safety Enhancements, CST updates, coordination topics with GREPECAS)
- Assign champions and drafting teams for each WP to ensure timely preparation

PA-RAST Preparatory Actions for RASG-PA/15

- Establish internal milestones (suggested):
 - 31 October 2025: Confirm topics and assign champions
 - 19 December 2025: Draft WPs available for internal PA-RAST review
 - 9 January 2026: Finalize and submit WPs to Secretariat
- During the asynchronous phase (19 Jan – 12 Feb 2026), monitor comments and prepare consolidated responses/errata for in-person deliberations
