Agenda Item 1: Review of the status of the Conclusions and Actions

The status of the conclusions and actions items of the previous SAM/IG Meetings will be reviewed.

Agenda Item 2: Global and regional context

The results of the 42nd ICAO Assembly will be analyzed, with emphasis on the eighth edition of the GANP. The participation and contribution of the SAM/IG in the programs and projects of GREPECAS will be evaluated, according to the latest advances of this regional group (CAR/SAM).

Agenda Item 3: Report on activities, deliverables and progress made by the GT – Interop and Subgroups

- a) Review of air navigation priorities in the CNS field.
- b) CNS Implementation. Progress of the Subgroups.
- c) GREPECAS project for the management of aeronautical frequencies.
- d) Regional activities related with CNS resilience, regional interoperability and ATM infrastructure modernization.

Under this agenda item, the implementation of the systems that support air navigation services will be monitored. Likewise, the activated Subgroups of the Interoperability Task Group (GT Interop) will present the progress and deliverables of the Subgroups CNS/AMHS, y MET/IWXXM.

In turn, the work carried out by the CNS/ANP Subgroup in the review of the information contained in Part III (CNS) of Volume II of the ANP CAR/SAM will be presented. Within the scope of the CNS/SUR subgroup, the progress of the active Ad-hoc Groups (GA CONOPS/Roadmap ADS-B, GA ADS-B Regulation and GA Technical Implementation) will be analysed. Likewise, the progress of the CNS/VOIP Subgroup will be presented. Aspects related to ATS surveillance, operational resilience, continuity of CNS services and evolution of regional IP-based architectures will also be considered.

Agenda Item 4: Report on GESEA and Subgroups activities and deliverables

Under this agenda item, the implementation of improvements for air navigation in the SAM region is monitored, in key areas of performance Efficiency and Capacity. The focus area of operational resilience is also addressed. Consequently, Subgroup 1 "Airspace Planning", Subgroup 2 "PANS-OPS", Subgroup 3 "ATFM" and Subgroup 4 "FF ICE Implementation" will present the progress of the activities resulting from their Virtual Meetings and the deliverables of the designated Working Groups (TFs).

Agenda Item 5: Work Plan 2026. Organization of the SAM/IG and contributing bodies

Schedules and Work Plans for the second half of 2026 and 2027 will be reviewed, regarding the tasks of GESEA and GT Interop. Improvements to the structure and organization of SAM/IG and its contributing bodies will be discussed.

Agenda Item 6: Other matters

Other matters related to the objectives of the SAM/IG and/or of interest to ATM/CNS Planning. Topics in the area of safety and environment. Including aspects related to cybersecurity, operational resilience, environmental sustainability and digital transformation of ANS services.
