**1. INTRODUCTION**

1.1 In accordance with the AASPG Procedural Handbook, the Sub-Group is required to regularly review its outstanding Conclusions and Decisions to ensure they remain current and to minimize their number, in line with the progress made in their implementation.

1.2 The AAO/SG is specifically tasked with conducting comprehensive reviews and updates of all Conclusions and Decisions relevant to the AAO Sub-Group, to ensure their continued relevance and alignment with current objectives.

**2. DISCUSSION**

2.1 The planning and implementation regional groups (PIRGs) must record their actions in form of Conclusions and Decisions as follows:

- (a) Conclusions deal with matters which, in accordance with the regional groups' Terms of Reference merit directly the attention of States, or on which further action is required to be initiated by the Secretary in accordance with established procedures.
- (b) Decisions relate to the internal working arrangements of the regional Groups and their subsidiary bodies.

2.2 As part of its mandate, the Secretariat of the Airspace and Aerodrome Operations Subgroup (AAO/SG) conducted a comprehensive review of all applicable Conclusions and Decisions since the twentieth meeting of APIRG, in line with the APIRG framework.

2.3 This analysis identified 119 Conclusions/Decisions that have either been implemented, are outdated, redundant, or no longer aligned with current operational or strategic priorities. As a result, these Conclusions and Decisions were deemed no longer applicable, officially closed, and no longer in force.

2.4 The list of Conclusions and Decisions identified as no longer applicable and officially closed is provided in Appendix 1 to this working paper.

2.5 The Status of implementation of the Conclusions and Decisions that are still applicable to the subgroup is presented in **Appendix 2** to this Working Paper.
