EXECUTIVE SUMMARY

This paper presents the status of the budget approved by the Steering Committee of the CODEVMET-AFI Project during its Fifth meeting (SC/5), held from 30 September to 2 October 2024, and the corresponding expenditures and contributions. It also provides an overview of the payment status of the Member States.

1. **INTRODUCTION**

- 1.1. During its fifth meeting (SC/5), the Steering Committee of the CODEVMET-AFI Project approved the budget for 2025 through Decision 5/08.
- 1.2. The paper provides an update on this approved budget, the related expenditures and received contributions for the period from 31 December 2024 to 30 September 2025.
- 1.3. Unless explicitly stated otherwise, all amounts in this paper are given in United States dollars.

2. **DISCUSSION**

- 2.1. The approved budget for 2025 stands as \$162,500 as provided in Appendix 1 to his working paper.
- 2.2. The fund balance stood at \$147,982 as of 31 December 2024.

- 2.3. The contributions received as at 30 September 2025 amount to \$10,379.74. The expenses include the assistance activities and meetings as presented in Appendix 2 and which costs is \$39 380,00.
- 2.4. The fund balance as at 30 September 2025 is \$118,981,74. Table 1 below provides the summary of the budget as at 30 September 2025.

2.5. The meeting may note that the fund balance shown in Table 1 results from the successful remote implementation of Activities 4.4, 5.1, 5.2, and 5.3 initially planned onsite as per Appendix 1, which generated cost savings. In addition, Activity 6.1 has been postponed to 2026.

2.6. Status of payment requests

- a) ICAO issues payment requests for the annual membership fees to the 12 active members. Should on-request services be required, corresponding payment requests will be issued as well. Appendix 3 provides the list of Participating Members, Active Members and Active Members having paid their 2025 contributions to the Project.
- b) As at 30 November 2025, a total amount of \$120,000.00 of annual membership fees is outstanding for 2025. Appendix 4 provides on outstanding annual payments since 2022.

2.7. Conclusion

- a) The project budget approved during SC/5 was not fully implemented as planned up to September 2025. The balance between the baseline and the actual expenditures are mainly due to certain activities being carried out remotely instead of onsite, as well as the rescheduling of others.
- b) As of 30 September 2025, the project shows a balance of approximately USD118,981.74, while outstanding arrears remain significant.
