ICAO’s eLibrary is the online digital publications repository that features SARPs on international civil aviation, along with Conventions and Related Acts. Currently, ICAO manages over 12,000 SARPs across the 19 Annexes which are updated as developments and innovations evolve.

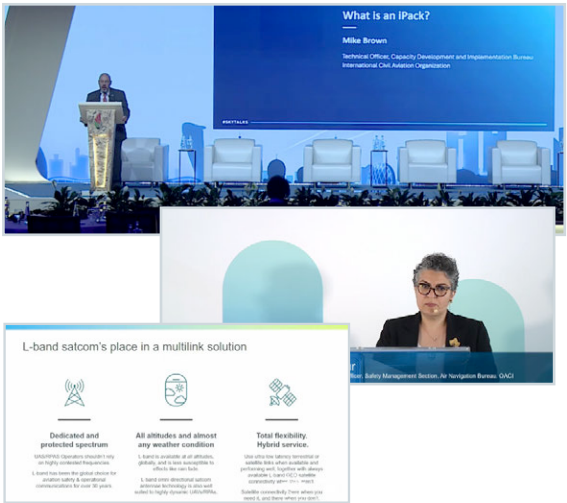


Skytalks Opportunities

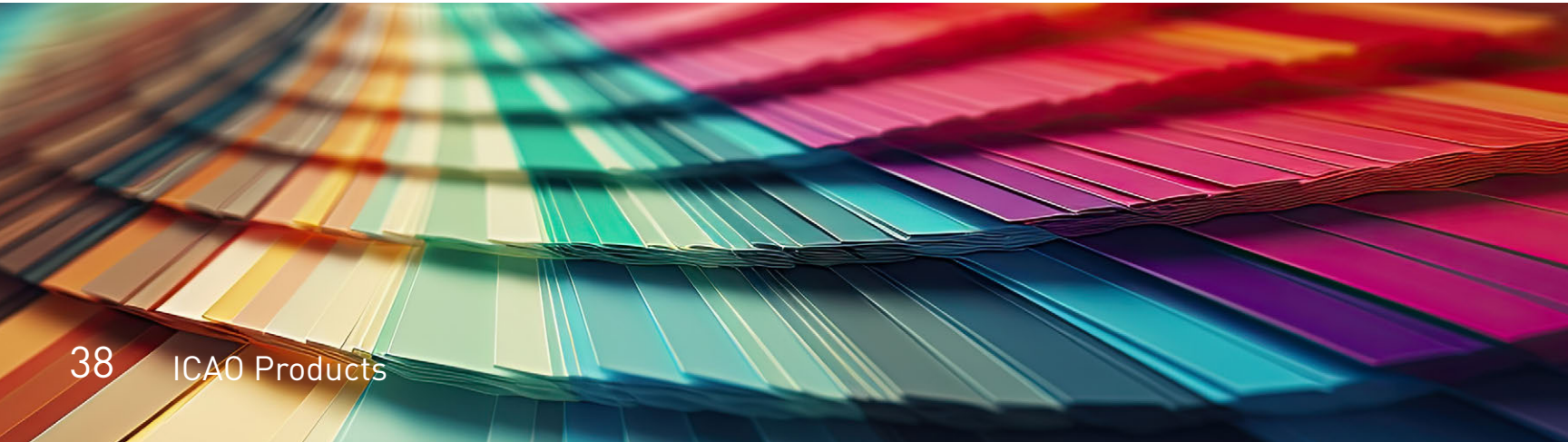
