

**DECLARATION BY THE ORGANIZATIONS OF THE UNITED NATIONS SYSTEM  
ON THE DEVELOPMENT OF HARMONIZED UNMANNED AVIATION  
FRAMEWORKS IN SUPPORT OF THEIR RESPECTIVE MANDATES, MISSIONS  
AND OBJECTIVES**

*Whereas* the deployment of unmanned aircraft systems (UAS), including remotely piloted aircraft systems, presents an opportunity for the organizations of the United Nations system to enhance their operational capabilities in support of their respective mandates, missions and objectives, including in the context of humanitarian assistance, disaster relief and rule of law;

*Whereas* there are varying levels of development and implementation of UAS strategies, policies, regulations, standards, recommended practices and guidelines (hereinafter “UAS Frameworks”);

*Whereas* increased coordination and harmonization regarding UAS Frameworks may assist the organizations of the United Nations system in the implementation of their respective mandates, missions and objectives; and

Whereas the organizations of the United Nations system listed in the annex to this declaration would wish to coordinate their efforts related to the development, harmonization and implementation of UAS Frameworks;

The organizations of the United Nations system listed in the annex to this declaration subject to, and in accordance with, their respective regulatory and legal frameworks, mandates, missions and objectives, hereby:

1. *acknowledge* the importance of facilitating the development and implementation of UAS Frameworks to facilitate the safe and efficient utilization of UAS by the organizations of the United Nations system;
2. *recognize* that collaborative and coordinated efforts by the organizations of the United Nations system are important to addressing the challenges and risks associated with the operation of UAS;

3. *recognize* that active participation, engagement, and the sharing of expertise by the organizations of the United Nations system in a coordinated and collaborative manner can contribute to the advancement of safe, efficient, and responsible UAS operations in support of their respective mandates, missions and objectives;
4. *recognize* the role of United Nations Aviation Technical Advisory Group (“UNATAG”) in advising the organizations of the United Nations system on aviation operational and safety matters and reviewing and amending the United Nations common aviation standards and procedures for relevance and consistency with international safety standards and operational requirements in accordance with its terms of reference;
5. *agree* that UNATAG will update the UN aviation standards for peacekeeping and humanitarian air transport operations to include relevant UAS Frameworks;
6. *agree* to:
  - a) continue to develop their respective UAS Frameworks with the view to facilitating safe and efficient conduct of UAS operations;
  - b) as far as practicable, support and coordinate their efforts related to the development, harmonization and implementation of UAS Frameworks, including with regard to safety of UAS operations, and will engage in collaborative efforts with organizations of the United Nations system in this respect;
  - c) establish a coordination forum as the strategic coordination mechanism for UAS Frameworks for the organizations of the United Nations system, and support and participate in the work and activities of the forum; and
  - d) coordinate with respect to mechanisms to exchange knowledge, best practices and lessons learned, and develop training programs to enhance the safety, efficiency, and effectiveness of the UAS operations.
