#### 1. INTRODUCTION

- 1.1. The meeting may recall that during the Nineth Edition of AFI week held in Libreville, Gabon, in July 2024, the AFI Plan and AFI SECFAL Plan Steering Committees meetings (AFI Plan SC/27 and AFI SECFAL Plan SC/13) established an Ad hoc Committee. The primary purpose of the Committee was to review the governance of the AFI Plan, the AFI SECFAL Plan and the HRDF; and propose strategies to fast-track the effective implementation of these initiatives.
- 1.2. The Extraordinary Meeting of the AFI Plan and the AFI SECFAL Plan Steering Committees, and the HRDF Management Committee, held virtually on 6 May 2025, reviewed and endorsed the Governance framework of the AFI Plans (AFI Plan, AFI SECFAL Plan and HRDF), proposed by the Ad Hoc Committee.

- 1.3. The roles and responsibilities of the newly established Steering Committee include amongst others, providing policy and strategic direction for the effective implementation of the AFI Plan, AFI SECFAL Plan and HRDF programmes. Additionally, the Steering Committee is responsible for approving the long-term goals, initiatives and specific targets of these programmes, including related projects and annual work programmes and budget. The steering committee is also responsible for resource mobilization.
- 1.4. This working paper presents the Provisional Agenda and Work Programme for the First Meeting of the Steering Committee of the AFI Plans for discussion and adoption.
