EXECUTIVE SUMMARY

This paper presents information related to the development, presentation to States and implementation of tailored-action plans to assist States under the review of the Monitoring and Assistance and Review Board (MARB).

In close collaboration with relevant ICAO Bureaux, the Regional Office Safety Teams (ROSTs) developed ICAO Plans of Actions tailored to each State under the review of the MARB. The plans developed have already been submitted to States and implementation activities were initiated following the approval by the States.

Action: The Steering Committee is invited to:

- a) note the information contained in the paper; and
- b) provide further instructions for the continued implementation of the ICAO Plans of Actions tailored to the needs and situations of the States under the review of the MARB in line with column 8 (Action required from the meeting) of Attachment A.

1. **INTRODUCTION**

- 1.1 During its eighth meeting, the Steering Committee noted that there was a process in place for the development of ICAO Plans of Actions tailored to the needs and situation of each State and was also informed of the status of development and presentation of the ICAO Plans of Actions to States.
- 1.2 The Steering committee further requested the Secretary General to undertake, in coordination with AFCAC and other partners and subject to acceptance by the States, implementation of the actions identified under the Plans.

1.3 The present paper summarizes the progress made in the development, presentation and implementation of the ICAO Plans of Actions tailored to the needs and situations of States under the review of the MARB since the eighth meeting of the AFI Plan Steering Committee.

2. SUMMARY OF PROGRESS FROM NOVEMBER 2011 – MARCH 2012

- 2.1 **Attachment A** to this discussion paper provides a list of States under the review of the MARB together with an update on the status of development, presentation and implementation of the ICAO Plans of Actions.
- 2.2 The ICAO Plans of Actions are generally divided into three phases: **immediate**, **near** and **long term**. In the immediate term, the objective is to address the major safety deficiencies by using Regional Office Safety Teams (ROSTs) and/or AFCAC Cooperative Inspectorate Scheme (AFI-CIS). The near term period is generally a continuation of the implementation of the State's Corrective Action Plan (CAP) which will continue to address the remaining deficiencies by using mostly AFI-CIS. The duration of each term is determined by the level of implementation of the CAP and availability of other individual and regional resources. The long term period is intended to provide a platform for ICAO and the State to continue to monitor the situation on an on-going basis to promote aviation safety and ensure that the State maintains its ability to comply with safety oversight requirements. This is mainly through projects (TCB or any other arrangements by the State) which will allow the State to develop capacity.
- 2.3 As of 19 April 2012, ICAO Plans of Actions have been developed for all States under the review of the MARB. Furthermore, the ICAO Plans of Actions tailored to the needs and situations of each State have been presented to 12 States in ESAF and 8 in WACAF.
- 2.4 With regard to acceptance of the ICAO Plans of Actions, 11 States in ESAF and 6 in WACAF have formally indicated their acceptance of the proposed Plans.
- 2.5 The objectives of the Regional Office Safety Teams (ROSTs) implementation activities are to specifically assist States in the implementation of the CAP in specific areas such as AGA, AIR, ANS, PEL, and OPS based on the needs identified during the initial evaluation and that served as a basis for the development of the ICAO Plans of Actions.
- 2.6 Implementation activities of the ROSTs have been conducted in 5 States (Comoros, Madagascar, Mozambique, Rwanda and Zambia) in ESAF and in 9 States (Benin, Cameroon, The Central African Republic, Congo, DRC, Equatorial Guinea, Gabon, Mauritania and Sierra Leone) in WACAF to initiate the implementation of the immediate phase of the accepted ICAO Plans of Actions.
- 2.7 The implementation of the ICAO Plans of Actions has now matured to near-term phase for some States and they are now ready for other interventions (One state in ESAF and One State in WACAF).
- 2.8 It should be noted that since the Eighth meeting of the Steering Committee ICAO Coordinated Validation Missions (ICVM) have been conducted in Mali and Benin and is confirmed for one State (Madagascar) in ESAF and for two States (DRC and Gabon) in WACAF.
