ADMINISTRATIVE PACKAGE FOR RATIFICATION OF OR ADHERENCE TO THE CONVENTION ON THE INTERNATIONAL RECOGNITION OF RIGHTS IN AIRCRAFT, SIGNED AT GENEVA ON 19 JUNE 1948

1) Full Name of Instrument:

Convention on the International Recognition of Rights in Aircraft, signed at Geneva on 19 June 1948 (ICAO Doc 7620)

2) **History**:

ICAO Assembly – 2nd Session, Geneva, 1 – 21 June 1948

3) **Summary**:

The purpose of this Convention is to facilitate the financing for the purchase of aircraft employed in international air services. The main characteristics of the Convention are the following:

- a) the protection of secured creditors (banks) who lend money on the security of aircraft (through the standard form of a mortgage);
- b) the protection of third parties dealing in or with aircraft against hidden charges;
- c) the definition and protection of privileged and priority claims against aircraft;
- d) the facilitation of the transfer of aircraft from one nationality to another.

4) Main reasons for ratification:

The Geneva Convention deals generally with the international recognition of rights in aircraft and is designed to secure recognition on an international basis of property and other rights in aircraft so that when an aircraft crosses a frontier, the interests of holders of such rights will still be protected (Articles I, II and IV). Acceptance of the principles of the Convention is expected to encourage investors to make financial assistance possible for the purchase of new aircraft to be employed in international civil aviation.

5) Entry into force:

The Convention entered into force on 17 September 1953.
