#### NOTES

- 1 Acceptance of the Protocol on the Authentic Trilingual Text of the Chicago Convention is deemed by virtue of adherence to that Convention, as provided by Article V of the Protocol.

- 2 Signed with reservation as to acceptance.
- 3 Declaration, pursuant to Article XIII, paragraph 2, of the Convention that Kazakhstan is not a producer State of plastic explosives.
- 4 On 21 January 2009, Kazakhstan deposited its instrument of accession in respect of the Convention only, without declarations. On 15 March 2011, Kazakhstan made subsequent declarations pursuant to Articles 39(1)(a), 39(1)(b), 39(4), 40, 53 and 54(2) of the Convention. In accordance with its Article 49(2), the Convention, as applied to aircraft equipment, enters into force for Kazakhstan on 1 October 2011, the date of entry into force for Kazakhstan of the Aircraft Equipment Protocol (Cape Town, 2001). On 16 November 2012, Kazakhstan notified of the withdrawal of its declarations under Articles 39(1)(a), 39(1)(b), 39(4), 40, 53 and 54(2) of the Convention, effective 1 June 2013, at which time subsequent declarations under Articles 39(1)(a), 39(1)(b), 39(4), 40, 53 and 54(2), will take effect.
- 5 Kazakhstan deposited its instrument of accession in respect of the Protocol on 1 June 2011 with declarations under Article XXX(1), (2) and (3).
