NOTES

- ¹ Declaration: By a Note dated 23/4/63, the Government of Cyprus declared that it considered itself bound by the Warsaw Convention (before Cyprus became independent, acceptance of the Convention was effected by the Government of the United Kingdom on 3/12/34).
- ² This date of deposit with the Government of the United Kingdom precedes the dates of deposit with the Governments of the USSR (now the Russian Federation) and the United States, namely 30/7/73 and 15/8/73.
- ³ Declaration, in accordance with Article XIII, paragraph 2, of the Convention, that Cyprus is not a producer State of plastic explosives.
- ⁴ On 6 September 2006, Cyprus deposited with IMO its Notification of Association as a User State which became effective on 6 October 2006. On 9 March 2017, Cyprus deposited with ICAO its Notification of Association as a Ground Segment Provider which became effective on 8 April 2017. On that date, the status of Cyprus as a User State ceased.
- ⁵ Upon ratification of the Convention, the Republic of Cyprus made the following declaration: “The Republic of Cyprus objects to the declaration deposited by the Republic of Turkey at the time of signature of the instrument on 18 September 2013, registered at the Secretariat General of the International Civil Aviation Organization, limiting the implementation of the provisions of the Convention on the Suppression of Unlawful Acts relating to International Civil Aviation (2010) only to the States with which the Republic of Turkey has diplomatic relations. The aforesaid declaration is contrary to the object and purpose of the Convention as it precludes the realization of the cooperation foreseen by the Convention between all State Parties, one of which is the Republic of Cyprus, and as such, the said declaration is invalid.”
- ⁶ Upon ratification of the Protocol, the Republic of Cyprus made the following declaration: “The Republic of Cyprus objects to the declaration deposited by the Republic of Turkey at the time of signature of the instrument on 18 September 2013, registered at the Secretariat General of the International Civil Aviation Organization, limiting the implementation to the provisions of the Protocol Supplementary to the Convention for the Suppression of Unlawful Seizure of Aircraft (2010) only to the States with which the Republic of Turkey has diplomatic relations. The aforesaid declaration is contrary to the object and purpose of the Protocol as it precludes the realization of the cooperation foreseen by the Protocol between all State Parties, one of which is the Republic of Cyprus, and as such, the said declaration is invalid.”
