³ At the time of deposit of its instrument of ratification, the Republic of Ghana made the following declaration in accordance with Article 2, paragraph 2 stating that “this Convention shall also apply where an aircraft in flight, other than on an international flight, causes damage in the territory of the Republic of Ghana, other than as a result of an act of unlawful interference.”

⁴ Upon depositing its instrument of accession, Ghana made a declaration pursuant to Article 40, paragraph 3, of the Convention, that “the total number of passengers that departed on international commercial flights from airports in

the territory of the Republic of Ghana in the previous year of 2016 was two million, one hundred and seventy-nine thousand, nine hundred and twenty-seven (2,179,927).”
