- <sup>3</sup> By a Declaration dated 16/10/89, deposited with ICAO on 12/12/89, the Government of Hungary withdrew the reservation made at the time of accession on 3/12/70 with regard to Article 24, paragraph 1, of the Tokyo Convention. The withdrawal of the reservation took effect on 12/12/89.
- <sup>4</sup> On 10/1/90, the Government of Hungary deposited with the Government of the United Kingdom and the Government of the United States instruments whereby that Government withdrew the reservations made at the time of ratification of The Hague Convention and the Montreal Convention with regard to Article 12, paragraph 1, and Article 14, paragraph 1, respectively, thereof. The withdrawal of the reservations took effect on 10/1/90.
