¹ Kenya deposited its instrument of adherence on 7/10/64, with validity as from 12/12/63, on which date it became an independent State (before Kenya became independent, acceptance of the Convention was effected by the United Kingdom on 3/12/34).

² The instrument of accession presented by Kenya on 5 July 1999 was deposited on 25 July 2002, the date of entry into force of the Protocol.

³ Declaration, pursuant to Article XIII, paragraph 2, of the Convention that Kenya is not a producer State of plastic explosives.

- ⁴ At the time of ratification, Kenya made declarations under Articles 39(1)(a), 39(1)(b), 40, 53 and 54(2). On 30 May 2007, Kenya withdrew its declaration under Article 39(1)(a), effective on 1 December 2007, and made a subsequent declaration under Article 39(1)(a), also effective on 1 December 2007.
- ⁵ At the time of ratification, Kenya made declarations under Article XXX(1), (2) and (3).
