- <sup>2</sup> Declaration, in accordance with Article XIII, paragraph 2, of the Convention, that the Republic of Moldova is not a producer State of plastic explosives.
- <sup>3</sup> On 26 June 2015, the Republic of Moldova deposited its instrument of accession in respect of the Convention only, without declarations. On 19 February 2019, the Republic of Moldova made a declaration pursuant to Article 54(2) of the Convention. On 19 February 2019, the instrument of accession by the Republic of Moldova to the Aircraft Protocol was accepted for deposit. Pursuant to Article 49(2) of the Convention and Article XXVIII(2) of the Protocol, both treaties will enter into force for the Republic of Moldova on 1 June 2019.
