- <sup>2</sup> Reservation: The Government of Ukraine does not consider itself bound by Article 24, paragraph 1, of the Tokyo Convention.  
Declaration dated 13/1/88 by the Ukrainian Soviet Socialist Republic (now Ukraine) that “the accession of the Ukrainian Soviet Socialist Republic to the Convention on Offences and Certain Other Acts Committed on Board Aircraft does not affect its rights and obligations under bilateral and multilateral agreements in force on the suppression of acts of unlawful interference with civil aviation, to which it is a Party”.
- <sup>3</sup> Reservation: The Government of Ukraine does not consider itself bound by Article 12, paragraph 1, of The Hague Convention.  
On 20 December 2022, a Notice was deposited with the Government of the United Kingdom by the Government of Ukraine whereby that Government withdrew the reservation made at the time of signature with regard to paragraph 1 of Article 12 of the Convention. The withdrawal of the reservation took effect on 20 December 2022.
- <sup>4</sup> Reservation: The Government of Ukraine does not consider itself bound by Article 14, paragraph 1, of the Montreal Convention.
