NOTES

- 1 Acceptance of the Protocol on the Authentic Trilingual Text of the Chicago Convention is deemed by virtue of adherence to that Convention, as provided by Article V of the Protocol.
- 2 Reservation: “In accepting the said Convention, the Government of the United Arab Emirates takes the view that its acceptance of the said Convention does not in any way imply its recognition of Israel, nor does it oblige to apply the provisions of the Convention in respect of the said Country”.
- 3 Signature effected with reservation as to acceptance.
- 4 Declaration, in accordance with Article XIII, paragraph 2, of the Convention, that the United Arab Emirates is not a producer State of plastic explosives.
- 5 At the time of accession, the United Arab Emirates made declarations under Articles 39(1)(a), 39(1)(b), 40, 52, 53 and 54(2) of the Cape Town Convention.
- 6 At the time of accession, the United Arab Emirates made declarations under Articles under Articles XIX, XXIX, XXX(1), XXX(2) and XXX(3) of the Cape Town Protocol.
- 7 Association with the Programme as a Ground Segment Provider.
- 8 At the time of accession, the United Arab Emirates made the following reservation:
