#### 1. INTRODUCTION

- 1.1 The meeting will recall that the President, on behalf of the Council, approved on 19 August 2016 Volume I of the AFI eANP (Doc 7474). The APIRG/22 Meeting, in its Conclusion 22/20, endorsed the Volume II of the AFI eANP; and requested States to provide timely inputs to Volume III once circulated, while complying with the established procedures for further amendments of the AFI eANP.
- 1.2 The twenty-fourth meeting of APIRG, taking note of the important changes introduced through the sixth edition of the GANP, urged States and the Secretariat to expedite the alignment of the Regional Air navigation Plan to the GANP.

## **2. DISCUSSION**

- 2.1 The approved Volume I and Volume II as well as the draft version of Volume III of the AFI eANP have been posted online on the ICAO ESAF and WACAF Regional Offices websites (<https://www.icao.int/WACAF/Pages/AFI-eANPs.aspx> and <https://www.icao.int/esaf/Pages/default.aspx>). The process for amendment of all three Volumes of the AFI Air Navigation Plan is detailed in Appendix A to its Volume I.

### *Update of the Volumes I and II*

- 2.2 The Volume I contains stable plan elements, the amendments of which require approval by the Council, and the Volume II, dynamic plan elements, whose amendments are approved through regional agreement involving the APIRG.
- 2.3 The meeting may note some inconsistencies of data in the various tables of the current version of the AFI eANP, due to the lack of information updating from States, hence the low pace of the amendment of the AFI Air Navigation Plan in comparison of the eANP of other ICAO Regions.

### *Development of the Volume III*

- 2.4 The APIRG/24 through its Decision 24/30, tasked the Secretariat, in coordination with the AAO and IIM Subgroups, to identify the applicable ASBU Elements and finalize the development of the Volume III of the AFI eANP as appropriate. The identification of the applicable ASBU Elements was carried out, as presented in the outcomes of the Sub-groups' meetings.
- 2.5 The draft Volume III of the eANP, including the applicable ASBU Elements, is presented for consideration by the meeting, as Appendix A to this working paper.

## **3. ACTION BY THE MEETING**

- 3.1 The meeting is invited to:
- a) Take note of the information presented in this working paper;
  - b) Review and endorse the Volume III of the AFI eANP; and
  - c) Urge States and Secretariat to expedite the updating of the Vol I and II of the AFI eANP, as appropriate, by March 2023.
