EXPLANATORY NOTES

Session 1 - Review of the last CAPSCA Africa meeting conclusions

The session will discuss the status of the implementation of the Conclusions and Recommendations of the 8th CAPSCA Africa meeting which was held virtually on 8-9 August 2022.

Session 2- CAPSCA Global updates

The session will discuss new developments on the CAPSCA Programme, including the ICAO 41st Assembly resolutions, the ICAO/WHO MOU and the HLCC recommendations among others.

Session 3: CAPSCA Africa Programme updates

The session will focus on the activities undertaken under the CAPSCA Africa Programme. The session will highlight initiatives related to the management of Public Health events in Africa as well as recent outbreaks.

Session 4- Activities, Achievements, Lessons Learnt

States and Organizations will present the status of the implementation of the IHR provisions as well as ICAO SARPS related to the public health events management. The session will focus on the activities so far conducted, achievements and lessons learnt from recent Public Health outbreaks (COVID 19, Ebola, Marburg and Monkey pox among others).

Session 5- Activities, Achievements, Lessons Learnt

The session whose objective is similar to the session 4 will be in a panel format. The session is aimed at eliciting feedback from participants on the effectiveness of the interventions and measures that were undertaken by States during the recent outbreaks. This session has been intentionally included to ensure participation from more States and organizations.

Session 6 – iPACKs & Airport Assistance Visits

The session will present the PHC and FAL iPacks as introduced by ICAO. The meeting will benefit from the experience of SMEs who delivered the IPACKs. The meeting will also be informed of the Airport Assistance visits mechanisms as well as the WHO’s JEE. IATA and ACI will also present their accreditation programmes related to public health.
