Yesterday's meetings, Wednesday, 28 September 2022

First Meeting of the Executive Committee

The Executive Committee opened its First Meeting in closed session at 0900 hours on Wednesday, 28 September 2022 and considered Agenda Item 10 (Contributions in arrears) on the basis of A41-WP/30 Revision No. 1 (with Addendum No. 1).

Mindful of the hybrid format of the proceedings of the 41st Session of the Assembly, and recognizing the importance of ensuring transparency and equal access to the deliberations by all Member States, in accordance with Rule 24 of the *Standing Rules of Procedure of the Assembly of ICAO* (Doc 7600), the Committee agreed that all subsequent meetings of the Executive Committee during the current Assembly would be convened in open session.

Third Plenary Meeting

The Third Plenary was held immediately following the First Meeting of the Executive Committee, which adjourned at 0930 hours. The Assembly approved the oral report presented by the Chairperson of the Executive Committee on the Committee's consideration of Agenda Item 10 (Contributions in arrears) on the basis of A41-WP/30 Revision No. 1 (with Addendum No. 1).

Under Agenda Item 8, general statements were then delivered by the Delegations of: Japan, South Africa, Austria, Zambia, United Kingdom, Nepal, Iceland, Mozambique, Sri Lanka, Uganda, Greece, Côte d'Ivoire, Dominican Republic, Cuba, New Zealand, Nicaragua, Brazil, Italy, Ukraine, Togo, Liberia and Guyana.

The Plenary also noted the announcement by the Delegation of Papua New Guinea, on behalf of the 18 Member States of the Pacific Islands Forum, launching the Pacific Regional Aviation Strategy 2022-2032, as well as the remarks of the ICAO Secretary General regarding the Organization's ongoing commitment to working in the region to support Pacific Small Island Developing States.

Second Meeting of the Executive Committee

At its Second Meeting, held on Wednesday, 28 September 2022 at 1400 hours, the Executive Committee considered Agenda Item 16 (Environmental Protection – General provisions, Aircraft Noise and Local Air Quality) on the basis of A41-WP/93 and A41-WP/95 presented by the Council and related papers. It agreed to recommend to the Plenary for adoption the revised Consolidated statement of continuing ICAO policies and practices related to environmental protection – General provisions, noise and local air quality proposed by the Council in WP/95, as amended during the discussion.

The Executive Committee then commenced consideration of Agenda Item 17 (Environmental Protection – Climate Change), which was documented in two papers presented by the Council (A41-WP/368 and A41-WP/369), and related papers. At the time of adjournment at 1725 hours, the Committee had not completed its consideration of this item, and as such, agreed to continue its discussion at a later meeting.

It was understood that Agenda Item 18 (Environmental Protection – CORSIA) would also be considered at a subsequent meeting of the Executive Committee.

First Meeting of the Administrative Commission

The Administrative Commission held its first meeting at 1330 hours on Wednesday, 28 September 2022 with Capt. Haitham Misto (Jordan) as its Chairperson. The President of the Council opened the meeting. Officers of the Secretariat were introduced by the Secretary of the Commission, Ms. Olga Nam.

Mr. Fred K. Bamwesigye (Uganda) and Capt. Chester Voo (Malaysia) were appointed as First Vice-Chairperson and Second Vice-Chairperson, respectively after being nominated by the Netherlands. Both nominations were seconded by Colombia.

The President of the Council, Mr. Salvatore Sciacchitano, introduced the Draft Budget for 2023, 2024 and 2025, followed by the presentation made by the Secretariat. The Commission considered the presentation and concluded that there were no objections to forwarding the related action items pertaining to the Draft Budget to the Assembly for approval.

In addition to the Draft Budget 2023-2024-2025 (item 45), all other scheduled agenda items were considered by the Commission.

Treaty Event

The second day of the ICAO Treaty Event took place on 28 September 2022. Instruments of ratification/accession were deposited by:

Peru for the Montréal Protocol 2014; and Greece for the 2016 Protocols amending Articles 50 (a) and 56 of the Chicago Convention.
