## **Fourth Meeting of the Executive Committee, Thursday 29 September**

At its Fourth Meeting, held on Thursday, 29 September 2022 at 1800 hours, the Executive Committee resumed its consideration of Agenda Item 18 (Environmental Protection – CORSIA). In light of the papers presented and subsequent deliberations thereon, the Committee agreed to recommend that the revised Resolution, Consolidated statement of continuing ICAO policies and practices related to environmental protection – CORSIA, be forwarded to the Plenary for adoption.

The Fourth meeting of the Executive Committee adjourned at 2045 hours.

## **Yesterday's meetings, Friday, 30 September 2022**

### **Second and Third Meetings of the Technical Commission**

The Technical Commission held its second and third meetings on Friday, 30 September 2022, at 0900 and 1400 hours, respectively. The Commission considered and completed its work on Agenda Item 30 (Aviation Safety and Air Navigation Policy) with working papers under group 3, Agenda Item 31 (Aviation Safety and Air Navigation Standardization), Agenda Item 32 (Aviation Safety and Air Navigation Regional Implementation Coordination Mechanisms) and Agenda Item 33 (Other issues to be considered by the Technical Commission).

At its next meeting, the Technical Commission will begin reviewing the report materials on Agenda Items 29, 30, 31, 32 and 33.

The fourth meeting of the Technical Commission will be held on Tuesday, 4 October 2022 at 0900 hours in the Assembly Hall, 4th Floor.

### **Second Meeting of the Legal Commission**

The Legal Commission held its second meeting on Friday, 30 September 2022, at 0900 hours. It completed its consideration of Agenda Items 42 and 43.

### **First Meeting of the Economic Commission**

The Economic Commission, at its first meeting on Friday, 30 September 2022 at 1400 hours, presided by its Chairperson, Mr. Juliano Alcântara Noman (Brazil), elected Ms. Elisabeth Landrichter (Austria) and Ms. Angie Ahmed A.M. Elyazzi (Egypt) as First and Second Vice-Chairpersons respectively.

The Commission completed consideration, under Agenda Item 34, the Annual Reports of the Council to the Assembly for 2019, 2020, and 2021 as well as the Supplement.

Under Agenda Item 35, Economic Regulation of International Air Transport — Policy, the Commission considered the recovery measures from the impact of the COVID-19 pandemic based on A41-WP/11 presented by the Council and related papers. It then considered liberalization and ICAO international agreements based on the report of the Council presented in A41-WP/13 and related papers, and continued with the discussion of the topic of consumer protection.

The Commission also commenced consideration of Agenda Item 36, Economics of Airports and Air Navigation Services — Policy, based on 41-WPs 11, 12, and related papers. At the time of adjournment at 1700 hours, the Commission did not complete its deliberations on this item.

The Commission agreed to resume its work at its second meeting on Saturday, 1 October 2022 at 1400 hours.
