1. INTRODUCTION

1.1 This working paper presents the Financial Statements of ICAO for 2020 along with the External Auditor's Report and opinion and the Secretary General's comments.

2. REPORTS OF THE EXTERNAL AUDITOR

2.1 The External Auditors have provided the Auditor's Report which contains an audit opinion on the Financial Statements of the Organization, without reservation, stating that the Financial Statements of the Organization for 2020 presented fairly, in all material respects, the financial position of the Organization as at 31 December 2020 and the results of its operations, and that the transactions of the Organization that came to their notice during their audit of the Financial Statements had, in all significant respects, been in accordance with the Organization's Financial Regulations and legislative authority.

2.2 The External Auditors produced a report which is presented in Part V under Addendum No. 2 entitled *Report of the External Auditor to the Assembly on the Audit of the Financial Statements of the International Civil Aviation Organization for the Financial Year Ended 31 December 2020*.

3. REVIEW BY THE COUNCIL

3.1 On 14 June 2021, the Council reviewed the Financial Statements of the Organization for the financial year 2020, and the Audit Report thereon (Document 10168). After careful consideration of the Financial Statements and the Report of the External Auditor to the Assembly as well as the Secretary General's comments to the Report, the Council agreed to transmit the document and to recommend action to the Assembly as reflected in the Draft Resolution in the Appendix.
