**REPORT OF THE TECHNICAL COMMISSION  
TO THE ASSEMBLY**

**General**

1. The Technical Commission held four meetings between 29 September and 4 October 2022.
2. Mr. Raul Medina Caballero (Spain) was elected Chairperson at the second Plenary Meeting of the Assembly. The Commission, at its first meeting, elected as First Vice-Chairperson Mr. Sulaiman Almuhaimeedi (Saudi Arabia) on a nomination by Oman and seconded by Jordan. On a nomination by Argentina, and seconded by Mexico, the Commission elected Mr. Luiz Ricardo de Souza Nascimento (Brazil) as Second Vice-Chairperson.
3. Representatives from some 184 Contracting States and 56 Observer Delegations attended one or more meetings of the Commission.
4. The Secretary of the Commission was Mr. S. P. Creamer, Director of the Air Navigation Bureau. Messrs. D. Guindon, Deputy Director for Monitoring and Oversight, C.
