## APPENDIX A

### TENTATIVE AGENDA AND EXPLANATION OF THE AGENDA ITEMS OF THE EIGHTH MEETING OF CIVIL AVIATION AUTHORITIES OF THE SAM REGION

(RAAC/8)

(Buenos Aires, Argentina, 23 - 25 April 2003)

#### **Agenda Item 1: Analysis of the new air transport scenario in the South American Region**

The meeting will receive updated information on the air transport situation in the Region after the events of 11 September 2001. Likewise, it will be informed on the activities being developed in the Air Transport Competitiveness Regional Committee (Post-Colloquium Committee) with regard to the solution of difficulties being faced by regional air transport.

#### **Agenda Item 2: Analysis of the ICAO AVSEC Programme and its impact in the Region**

Aviation Security (AVSEC) is a matter of high priority in ICAO's work programme. This meeting will examine the worldwide AVSEC activities being developed by ICAO, as well as their impact at regional level. In addition, a review will be made to the activities being carried out by the GREPECAS AVSEC Committee.

#### **Agenda Item 3: Safety oversight**

Under this Agenda Item, the meeting will examine the level of States preparedness with respect to the audits incorporated in the Universal Safety Oversight Audit Programme (USOAP) in the AGA and ATM fields, emphasizing in the importance that States follow-up on the aerodrome certification process. In addition, the meeting will receive information on the activities being carried out in the Regional Safety Oversight Cooperation Programme.

#### **Agenda Item 4: Regional Air Navigation Plan – Transition to the CNS/ATM Systems**

Under this item, the meeting will be informed on the status of implementation of the RNAV and RNAV/RNP routes, matters in practice with the support of RLA/98/003 regional project. It is also expected that the meeting discuss measures to continue enhancing the implementation of the ATS quality assurance programmes. In addition, information will be provided on the status of operation of the South American Digital Network, which will have commissioned, by the date of the meeting, all AFS communications services in the Region.

With regard to GNSS augmentation planning, it is expected that the meeting receive information on the progress made by RLA/99/009 regional project, and on the activation of a new EGNOS trial platform. Two international conferences important for the implementation of the CNS/ATM systems will be held during 2003: the ICAO Eleventh Air Navigation Conference and

the ITU World Radiocommunication Conference (WRC-2003), over which the meeting should exchange points of view on the basis of information to be presented.

**Agenda Item 5: Review of regional activities with regard to reduction or elimination of deficiencies identified in the air navigation services**

The ICAO Council has recognized and considered of extreme importance the matter of solving air navigation deficiencies. In this respect, the meeting will examine the status of implementation of RAAC/7 Conclusion 7/13, on the basis of information to be presented by ICAO. It is expected that additional measures to those already agreed to be discussed, with the aim of enhancing the ICAO/States mechanism regarding the coordination required for the taking of necessary decisions/corrective measures permitting a progressive reduction of the deficiencies affecting the implementation of the CAR/SAM Air Navigation Plan.

**Agenda Item 6: Review of institutional aspects related with the implementation of CNS/ATM systems**

Under this Agenda Item, the meeting could examine, in the light of the work carried out by RLA/98/003 and GREPECAS, institutional aspects for multilateral arrangements that could be elaborated in the medium term and that could be applicable for the Region, taking into consideration the current provisional arrangements made for the REDDIG and the CARSAMMA agency. In this sense, it would be of benefit that the meeting express its points of view with regard to a regional institutional framework for the future administration of air navigation services, under a multinational or other type of agreement permitting a cost/efficient implementation of air navigation services within the ICAO CNS/ATM systems concept.

**Agenda Item 7: Follow-up on the implementation of conclusions adopted by previous RAAC meetings**

It is expected that the meeting, under this item, thoroughly review the valid RAAC conclusions, as well as their status of implementation, and formulate measures permitting to put into practice those still valid and not yet implemented.

**Agenda Item 8: Other matters**

The meeting could examine any other matter not related with the above items.
