**Agenda Item 1: Optimization of the ATS routes structure and revision of the results of SAM/IG/1 Meeting**

The meeting will have the opportunity to start the development of the transition of an air traffic management with ground-based systems to another one based on aircraft performance. Under this agenda item, the meeting will evaluate the current ATS routes network and will review the improvements to optimise the same.

It shall also evaluate the implementation initiatives carried out by States on this matter, As a result of the SAM/IG/1 Meeting, coordination is pending on the following routes, and it is expected that Ad-Hoc Groups conformed (IATA and States involved) provide the information, in order to initiate the corresponding amendment process: Also, under this agenda item, the meeting will revise the progress reached regarding the implementation of the conclusions formulated in the SAM/IG/1 Meeting and other matters related with Regional Project RLA/06/901.

**b) REVISION OF THE RESULTS OF THE SAM/IG/1 MEETING**

**Agenda Item 2: Implementation of performance-based navigation (PBN) in the SAM Region**

Under this agenda item, the meeting/workshop will take pertinent actions, in order to continue with en-route PBN, terminal areas and approach implementation, as required. The opportunity will be taken to review the action plan developed during the First Meeting of the SAM Implementation Group (SAM/IG/1). The meeting shall also review the guidance material developed by Project RLA/06/901 in order to execute the implementation.

This task is related with the following Global Plan Initiatives: performance-based navigation (GPI-5), Dynamic and flexible management of ATS routes (GPI-7), terminal area design and management (GPI-10), RNP and RNAV SIDs and STARs (GPI-11), FMS-based arrival procedures (GPI-12), and navigation systems (GPI-21).

**Agenda Item 3: Standards and procedures for performance-based navigation operations approval**

Under this agenda item, the meeting will review matters related with RNAV and RNP operations and airworthiness approval and harmonize the documentation at a regional level on this particular. It shall develop the work programme of the OPS/AIR working group and the progress in the preparation of guidance material and training programme prepared by Project RLA/99/901 with regard to RNP operations approval for air operators.

This task is related with Global Plan Initiative: performance-based navigation (GPI-5).

**Agenda Item 4: Implementation of air traffic flow management (ATFM) in the SAM Region**

The meeting shall evaluate the improvements that might be introduced, in order to balance demand and capacity, and to this end it shall study the roadmap for the implementation of air traffic flow management (ATFM), as well as the action plan approved by the SAM/IG/1 Meeting on this matter. It shall review the activities established in Phase 1 of the programme for effective implementation of the strategic ATFM in airports at a regional level, in order to improve airspace capacity and operational efficiency. The meeting will also evaluate guidance material developed by Project RLA/06/901. This activity is related with Global Plan Initiative: Air traffic flow management (GPI-6).

**Agenda Item 5: Assessment of operational requirements in order to determine the implementation of communications and surveillance (CNS) capabilities improvement for en-route and terminal area operations**

The meeting will review the action plan models for improvement of communications systems and surveillance systems, for en-route and terminal area operations, and shall analyse the status of implementation of the same (SAM/IG/1-5). It will also analyse, based on the foreseen operational requirements the improvements on navigation systems and shall elaborate an action plan on this respect. This activity is related with the following Global Plan Initiatives: performance-based navigation (GPI-5), air traffic flow management (GPI-6), dynamic and flexible management of ATS routes (GPI-7), Situational awareness (GPI-9), implementation of data link applications (GPI-17), aeronautical information (GPI-18), and communication network infrastructure (GPI-22).

**Agenda Item 6: Operational implementation of new ATM automated systems and integration of the existing systems**

Under this agenda item, the meeting will be review the action plan for the implementation of regional interconnection of automated systems (Conclusion SAM/IG/1-7), and will analyse the progress in the preparation of a model document of SAM automated systems requirements, which contains common basic functionalities. This activity is related with following Global Plan Initiatives: air traffic flow management (GPI-6), dynamic and flexible management of ATS routes (GPI-7), Situational awareness (GPI-9), decision-making support systems and alert systems (GPI-16), Implementation of data link applications (GPI-17), Aeronautical information (GPI-18) and communication network infrastructure (GPI-22).

**Agenda Item 7: Impact on ACCs due to multiple reception of the same flight plan**

The meeting will be able to review the impact on safety produced in automated systems upon multiple reception of flight plans of a same flight, normally coming from international commercial air transport companies, and their relationship with the different ATS messages and the ATFM.

**Agenda Item 8: Other business**

Under this agenda item, the meeting will be able to review matters which have not been discussed in the previous agenda items.
