EXPLANATORY NOTES

Agenda Item 1: Implementation of provision of Electronic Terrain and Obstacle Data (e-TOD)

Under this part of the Agenda, the progress on the compliance of regulations of ICAO Annex 15 by States concerning the required areas of survey will be analysed. States shall present progress achieved in their e-TOD implementation plans as well as Area 2 terrain and obstacle survey, to be published by 12 November 2015.

Agenda Item 2: Implementation of systems for Aeronautical Information Data Exchange and Aeronautical Data

Under this subject, the current status of GREPECAS Project G2 on implementation of systems for the exchange of information and data through protocols will be analysed. AIXM documentation and the action plan to carry out the implementation project will be analysed.

Agenda Item 3: Implementation of the Quality Management System in AIM units

Under this Agenda item, the meeting will deal with States that have not yet achieved implementation of quality management in the AIM and are delayed with regard to the roadmap for migration from AIS to AIM. States that have not implemented quality management must submit to the meeting a detailed action plan, establishing tasks carried out, pending tasks, the dates and resources assigned for its execution.

Agenda Item 4: NOTAM Contingency Plan, AIM deficiencies and ICARD system.

Under this Agenda item, States that have not implemented the NOTAM Contingency Plan shall present their proposals to activate bilateral or multilateral coordination required, in order to ensure continuity of NOTAM issuance in contingency. Likewise, States shall present an action plan for AIM deficiencies and their actions to avoid duplication of 5LNC codes in the ICARD system.

Agenda Item 5: Update on information concerning progress in the implementation of automated systems and other requirements according to Annex 15

Under this subject, a follow-up on the implementation of automated systems and tools such as GIS, its use and training performed, will be conducted.

Agenda Item 6: Analysis of objectives, metrics and dates for the implementation of elements regarding second phase of the plan for the transition of AIS to AIM: digital

Under this item, basis of national plans for the implementation of digital phase within ASBU block B0-DATM will be established.

Agenda Item 7: Other business

Under this subject, the meeting will be able to review other aspects which have not been considered in the previous agenda items and that are related with the matters under analysis.
