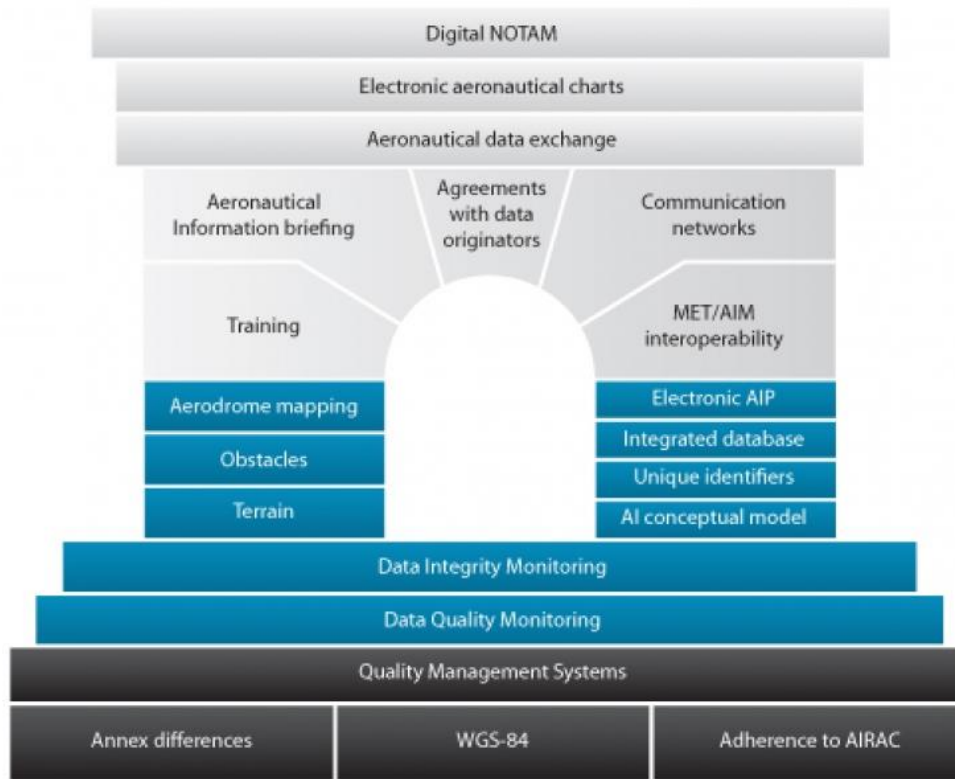

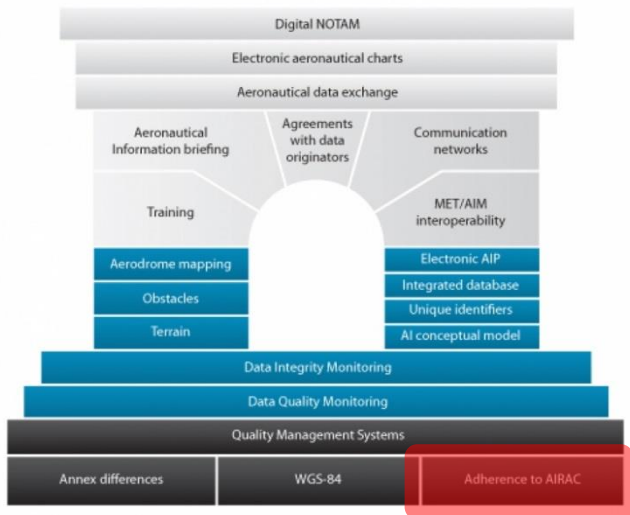

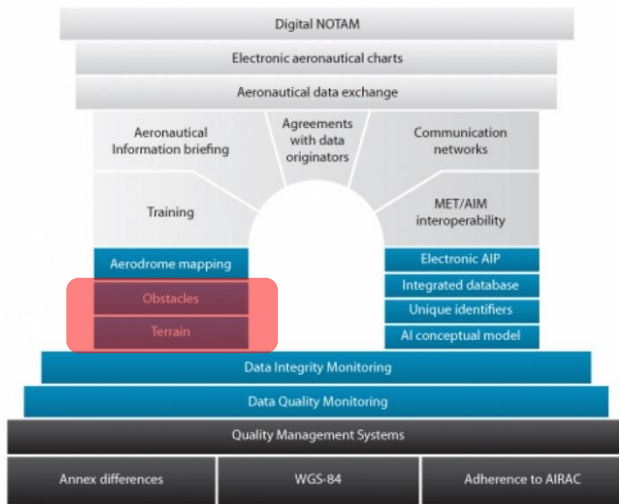
AIS to AIM Roadmap

- Insufficient planning and coordination, slow means of communication, etc.

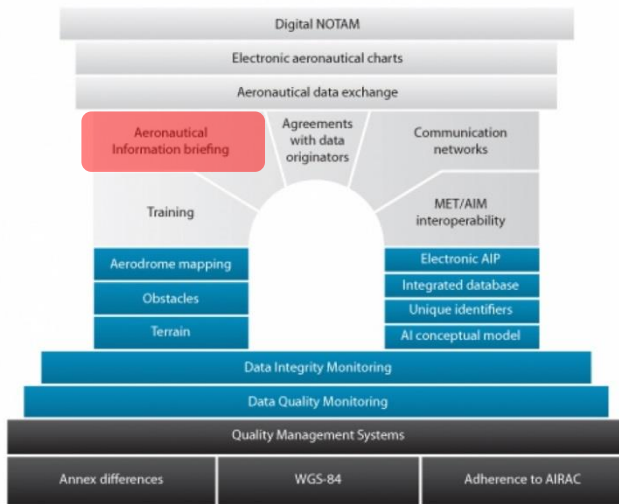
AIS to AIM Roadmap



- Very challenging requirements to meet in terms of accuracy, resolution, quality and availability of the data
- More work needed in requirements to support standardized implementation.

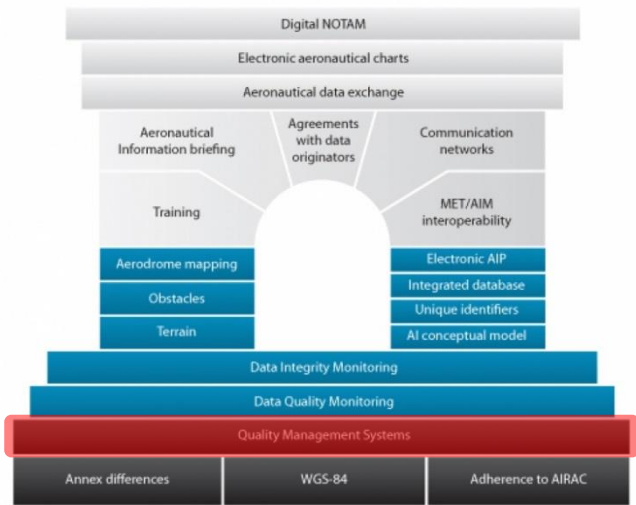
AIS to AIM Roadmap
