SUMMARY

This working paper presents for consideration and approval of the Meeting a Draft Agenda, schedule and working method for the Eighteenth Workshop/Meeting for the SAM Implementation Group (SAM/IG/18).

1. **Agenda**

1.1 The Tentative Agenda of the Eighteenth Workshop/Meeting of the SAM Implementation Group (SAM/IG/18) was distributed to all States, Territories, international organizations and the industry with letter SA5603 on 22 August 2016 and is attached as **Appendix A** to this working paper.

2. **Working methods**

2.1 For the development of this meeting, it is expected to work in plenary session, and in *Ad-hoc* groups, in order to analyse specific issues.

2.2 During the course of the meeting, a Summary of Conclusions will be prepared for its distribution to States and International Organizations interested.

2.3 Administrative aspects and documentation processing of the meeting will be in charge of ICAO Secretariat and the Working Groups Rapporteurs.

3. **Work schedule**

4.1 The meeting is invited to consider and approved the Agenda and working programme proposed for the SAM/IG/18 presented as Appendix A and B respectively.

EXPLANATORY NOTES

Agenda Item 1: Follow-up to conclusions and decisions adopted by SAM/IG meetings and the new Electronic Air Navigation Plan (eANP)

The Meeting will review the status of application of conclusions and decisions adopted during the Sixteenth Workshop/Meeting of the SAM Implementation Group (SAM/IG/17), as well as the valid conclusions and decisions from previous SAM/IG meetings. In addition, the tasks to be performed by States regarding the development of the new electronic Air Navigation Plan (eANP) will be presented.

Agenda Item 2: Optimization of the SAM airspace

- a) **PBN en-routes**
- b) **PBN in Terminal Areas**
- c) **PBN proceedings**

Under this Agenda Item, the Meeting will discuss the progress in the implementation of the Action Plan for the Optimization of Airspace presented in Appendix B of Agenda Item 3 of the SAM/IG/14 Meeting report. The results of the Second PBN Implementation Workshops (PBN/IMP/2) and the PANS-OPS Workshop, carried out in Lima, Peru, from 12 to 16 September 2016 under the auspices of RLA/06/901 Regional Project, will be presented. Regarding PBN project, States should present for its analysis the status of development of the PBN design of TMA and/or other airspaces chosen by the SAM States. According to Conclusion SAM/IG/14-4 (*Follow-up of the PBN goals established in the Bogota Declaration*) the States are expected to present the status of SID and STAR PBN, as well as the implementation of the APV Approach Procedures, with a view to achieving the goals of the Bogota Declaration. States can take advantage of this meeting to update their operational letters of agreement (LOAs). Related ASBU: B0-APTA, B0-FRTO, B0-CDO, B0-CCO.

Agenda Item 3: Implementation of Air Traffic Flow Management (ATFM)

Under this Agenda Item, the Meeting will follow-up and review the implementation of ATFM based on the action plan presented on Appendix B of Agenda Item 3 of SAM/IG/15 meeting report. The Meeting will analyse the practices used by the States in the application of ATFM measures. ASBUs related: B0-ACDM, RESQ-B0, B0-FRTO and B0-NOPS.

Agenda Item 4: Assessment of operational requirements to determine the implementation of improvements in communications, navigation and surveillance (CNS) capabilities for operations in route and terminal area

The Meeting will analyse the progress in the status of implementation of the activities referred to in the Action Plan for the Interconnection of Systems AMHS in the SAM Region and the goals expected by 2016 according to the priorities of implementation in this regard considered in the Bogota Declaration. On this respect States are expected to report the activities carried out for the AMHS implementation as well as the planning to complete it. At the same time, the meeting will be informed on the performance of the regional digital network (REDDIG II) and the activities accomplished by the regional project in charge of the network. Furthermore, progress in activities regarding following GREPECAS projects and

the necessary requirements for its fulfilment will be presented: Projects C2– *Improve ATM Situational Awareness*; D1 *Architecture of the ATN*; and D2 - *ATN Ground-Ground and Ground-Air Applications*. Finally the results of the Workshop for the implementation of navigation infrastructure to support PBN and GNSS precision approach operations in the NAN/CAR/SAM regions will be presented. Related ASBUs: B0-FICE, B0 ASUR and B0-APTA.

Agenda Item 5: Operational implementation of new ATM automated systems and integration of the existing systems

The Meeting will analyse the progress in the action plan for AIDC implementation since SAM/IG/15 meeting and the required actions to achieve the implementation priorities set on the Bogota Declaration. Since the completion of the implementation is foreseen by the end of 2016, States are expected to report the activities carried out and the planning to complete such implementation. The results of the Second AIDC Implementation Meeting hold in Lima, Peru, from 21 to 23 September 2016, will be presented. Related ASBU: B0-FICE.

Agenda Item 6: Other business

Under this Item, the Meeting will review related subjects not discussed in the afore indicated Agenda items.
