



## **State Safety Programme (SSP) Workshop**

**Georgetown, Guyana  
10 to 14 July 2017**

**PHASE 1 – CASE STUDY N° 02**

**SSP implementation plan**

**A. OBJECTIVES:**

- That participants become familiar with the development of the SSP implementation plan.
- That working groups complete the SSP implementation plan in accordance with Appendix 7 to Chapter 4 of ICAO Doc 9859 – Safety management manual.

**B. GENERAL INSTRUCTIONS:**

1. Read the instructions provided for the case study and designate a secretary and team leader in each group.
2. Exchange ideas and concepts, and reach consensus on the assigned case based on the information provided.
3. Once the above has been completed, the team leader or a designated participant shall present the results of their work.

**C. CASE STUDY N° 2: SSP IMPLEMENTATION PLAN**

Working groups shall complete the SSP implementation plan in accordance with Appendix 7 to Chapter 4 of Doc 9859, taking into account the following documents and the reality of the State aviation regulatory and administrative organisations.

- Primary aviation legislation
- Annex 13
- Annex 19
- Doc 9859 - SMM, Appendix 7, Chapter 4
- Other documents as may be deemed appropriate.

**D. PRACTICAL EXERCISE:**

The practical exercise must be completed assuming that the participants are representatives of the State aviation regulatory and administrative organisations and the GCAA (first line personnel, technical coordinators), whose role is to promote SSP implementation from the planning phase to completion. The SSP place holder organisation, together with the department/office responsible for SSP administration (Safety directorate), must take charge of the SSP implementation team following implementation. The functions of the implementation team include to:

- foster SSP implementation from the planning phase to completion;
- coordinate the gap analysis process;
- develop the SSP implementation plan;
- assure SSP training of the implementation team; and
- monitor and report on progress made in SSP implementation

Using Appendix 7 to Chapter 4 of Doc 9859, complete the SSP implementation plan of Guyana.
