I have the honour to address to you to inform you that this ICAO Regional Office has programmed the Third national continuous monitoring coordinators (NCCM) regional meeting of the Universal Safety Oversight Audit Programme (USOAP) continuous monitoring approach (CMA), to be held at the ICAO South American Regional Office, in Lima, Peru, from 16 to 20 July 2018.

During the first two days, 16 and 17 July 2018, the Israel CAA has been invited to carry out the workshop ***The road to a competent functioning CAA.***

This workshop has as objective to develop each participant's knowledge about how to lead a high-level and sustainable effective restructuring process, that would create a solid base for a safety surveillance system controlled by a competent and effective Civil Aviation Authority, in conformity with the standards and recommended practices (SARPS) of the Annexes to the International Civil Aviation Convention.

Following the referred workshop, the SAM States would have the opportunity to inform the participants about their progress in the improvement of the effective implementation (EI) of the eight (8) critical elements of a safety oversight system, specifically the States will present the progress in completing the Corrective Action Plan (CAPs) and all the protocol questions (PQs) conforming the eight (8) CMA USAOP audit areas.

In this regard, I am pleased to invite the NCMCs of your State, principal and alternate, to deliver the above mentioned presentations.
