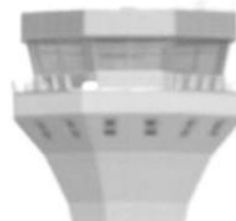
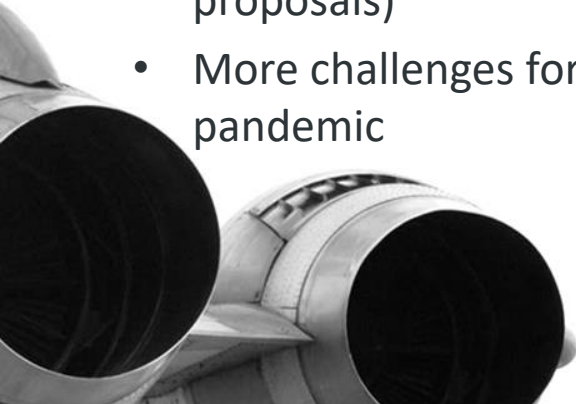

Resource Mobilization and COVID-19 recovery support - Considerations

- The implementation of the ICAO developed measures and recommendations regarding COVID-19 recovery lies primarily with States
- Resource Mobilization (RM) comes into play when **States express interest** in ICAO's support of their aviation restart, recovery and resilience implementation efforts
- RM needs active engagement of interested States in the process (e.g. developing proposals)
- More challenges for RM due to the underlying economic uncertainty caused by the pandemic

- ICAO is considering financing some iPACKs with own resources (cost savings)
- An ICAO major State donor has provided initial funding towards the deployment of a number of iPACKs
- ICAO is constantly advocating with States and International Institutions to secure further resources to support States
