In coordination with the Surveillance Task Force (NACC/WG/SURV/TF) of the North American, Central American and Caribbean Regional Working Group (NACC/WG), I wish to invite your Administration to participate in the *NAM/CAR/SAM Workshop on the Development of the regulation for the implementation of Automatic Dependent Surveillance – Broadcast (ADS-B) (ADS-B-Imp)*, to be convened at the ICAO NACC Regional Office, from 17 to 21 July 2023. This workshop will be supported by the Federal Aviation Administration (FAA) of United States and the Central American Corporation for Air Navigation Services (COCESNA).

This workshop aims to support States who have already implemented ADS-B stations in the development or review of their regulation in order to conclude this implementation. Attendance of the States and Territories of the ICAO NAM/CAR/SAM Regions that are in the process of implementing ADS-B is expected, as well as their specialists in surveillance systems, aircraft certification and development of regulations, and operational personnel involved in the commissioning of ADS-B.

Participants are invited to share their existing regulation for discussion and exchange at this workshop. The working languages of the Workshop will be English and Spanish, and simultaneous interpretation will be provided if sufficient participants of both languages provide timely registration.
