4. Transportation

At Jorge Chávez International Airport, we recommend using Taxi Green, whose central desk is located at the airport, near the international passenger exit. The fare to Miraflores or San Isidro (hotel areas) and vice versa is approximately US\$20.00.

Participants should arrange transportation by taxi or walking, depending on the location of their chosen hotel, to and from the Regional Office. The recommended company for city transfers is Taxi Satelital, Tel: +511 355-555. Ride-sharing platforms like Uber and Cabify are also available via mobile apps, for payment in cash (soles) or directly charged to credit cards.

In the city, there are independent or informal taxi drivers who do not belong to any company, and they do not provide security or guarantees. If you opt for an informal taxi, please be

aware that you are exposing yourself to a high level of risk.

6. Passport, Visa, and Vaccination Requirements

For entry into the country, a valid passport and visa are normally required. However, it is advisable to check with the Peruvian embassy or consulate in your home country for specific requirements. Please note that it is not possible to obtain entry visas upon arrival in Peru. Additionally, check if you require the yellow fever vaccination or any other vaccinations.

7. Currency Exchange and Credit Cards

The currency unit in Peru is the Peruvian Sol (S/). Please refer to <http://www.peru.gob.pe/> for current exchange rates. Credit cards such as American Express, MasterCard, VISA, Diners Club, etc., are usually accepted at hotels, shops, and restaurants. Traveler's checks should be exchanged at currency exchange offices or banks.
