4. **Opening of the meeting**

The opening session of the Meeting will be held on April 23, 2024 at 9:00 a.m. in the Plaza Olivar Room of the Sonesta El Olivar Hotel.

6. **Weather**

In the month of April, the weather in Lima is warm during the day and at night, with average minimum temperatures of 20°C and maximum temperatures of 25°C.

7. **Currency exchange**

The national currency is the Nuevo Sol. The exchange rate for the month of April 2024 is S/ 3.68 per US\$1.00, subject to daily variations, so it is suggested to see the updated exchange rate at the following link: sbs.gob.pe/app/pp/SISTIP_PORTAL/Paginas/Publicacion/TipoCambioPromedio.aspx

It is advisable to make the exchange always in Hotels, Banks and authorized Exchange Houses. Local commerce does not accept foreign currency.

8. **Credit Card**

International credit cards usually accepted in hotels, stores and restaurants are: Visa, Diners Club, MasterCard and American Express.

9. **Hosting**

The locations for hotels recommended due to their road connectivity, nearby commerce, hotels and banks, are the districts: San Isidro and Miraflores.

Regarding hotels, an agreement rate will be provided according to the attached list and the "Corporate Rate for ICAO" must be requested when making the reservation.

The rates shown below may vary due to the fluctuation of the US dollar.

Foreigners, when paying for the hotel in US dollars, must present their passport or identity card and air ticket to be exempt from paying the tax (IGV).

10. Transportation

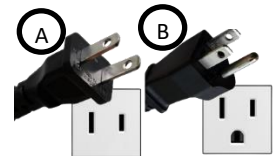

12. Business hours

General stores are open Monday through Friday from 9:00 am to 7:00 pm and on Saturdays from 10:00 am to 2:00 pm. Shopping malls and department stores are open from Monday to Sunday from 10:00 to 22:00 hours. Banks are open from 9:00 am to 6:00 pm, Monday to Friday and Saturday from 9:00 am to 1:00 pm.

13. Electricidad

Electricity in Peru is 220 / 60Hz. The plugs are type A and B sockets. It is advisable to bring a laptop adapter in case it is necessary.



14. Medical Insurance

Participants must have medical insurance with COVID coverage in Peru, as ICAO and the Host will not cover these expenses.

16. Travel Documents

According to the country of origin, participants must be accredited with the documents used to enter the country (Passport, DNI, Citizenship Card or equivalent documents).

There are countries that require VISA for entry, so it is recommended to visit the following website of the Ministry of Foreign Affairs of Peru: <https://www.consulado.pe/paginas/Inicio.aspx> Where Visa is required, arrangements should be made well in advance.

17. Gratuities and Taxes

The recommended tip in restaurants is 10% of the expense incurred.

In general, the tip is suggested at the end of the bill and is voluntary. Sales and services are subject to Value Added Tax (IGV) which is currently 18% and is generally included in the price to be paid. In transportation (cabs or others) it is not customary to tip drivers, leaving it to the passenger's discretion.

18. Security Recommendations

The security recommendations are common to all cities, such as carrying only the necessary money, not unnecessarily displaying valuable jewelry, cameras, cell phones. For transportation, the use of formal public transportation (cabs) is recommended.
