**Agenda Item 1: Follow-up of Actions Taken by the AIS/ MAP SG/9 Meeting**

**Agenda Item 3: Review of Planning Aspects and the Transition towards AIM**

During this discussion the following aspects on the planning of issues that have an effect on the aeronautical information services will be reviewed: follow-up to the actions derived from the Recommendations of the Eleventh Air Navigation Conference; the production of electronic charts; the ICAO/PAIGH cooperation project for the production of 1:1000,000 and 1:500,000 VFR aeronautical charts; and the application of the human factors in the AIS services. **Agenda Item 4: Review of Implementation Aspects**

Under this agenda item, the AIS/MAP Subgroup will review aspects related with the implementation of several issues that have an effect on aeronautical information services, such as the determination of the Terminal Phase of the implementation of NOTAM Data Banks by the States; the list of deficiencies and the development of action plans in order to correct them; the compliance with the AIS/MAP requirements of the CAR/SAM ANP/FASID Tables; and the development of an implementation plan of a quality system, taking as reference the Conclusions of the ACG/5 Meeting, the review of FASID Table AIS-4 with regard to the AIS/MAP/SG/9 Meeting and GREPECAS Conclusion 12/5.
