1 INTRODUCTION

1.1 The group will recall conclusion 14/5 formulated at the SCRAG/14 meeting in which it was agreed that the group would formally review the status of payments for the current year at each SCRAG meeting.

1.2 Whilst the current year's calculations are not strictly relevant to the calculation of the following years assessment, it is important to identify those states who have not yet paid their invoices and to consider appropriate follow up actions.

1.3 This paper appraises the group of the status of payments in relation to 2025 for the invoices issued in January 2025.

2 DISCUSSION

2.1 Invoices below 30 GBP

2.1.1 At SCRAG 19 the administrative cost of billing States for small amounts was reviewed, and it was proposed to limit invoicing to outstanding balances that surpass GBP 30 (Conclusion 19/6).

- Cyprus and Eswatini were notified by letter that their 2025 share of the SADIS costs would be amalgamated their invoice for the following year(s).

2.2 Late payment of invoices

2.2.1 The SADIS Provider believes it is important that States be encouraged to pay their invoices promptly. Whilst the SADIS Agreement strictly requires payment within 1 month of the date of the Invoice (Article XII, section 3), action to terminate the service to a State can only be taken at the end of that calendar year (Article XIII).

- 2.2.2 Other invoices of note:
- China withdrew from using SADIS on 1 January 2024. The credit shown for them relates to an overpayment made in 2023 has been returned to them.
- 2.2.3 Prompt payment reduces the administrative resource necessary to recover outstanding amounts. Twelve States are currently being pursued regarding their outstanding 2025 invoices and are at risk of disconnection if payment is not made by the 10 February 2026 (the proposed termination date).
- 2.2.4 It is also to the benefit of the SADIS Community (which funds the SADIS service), that States who cannot (or will not) pay their SADIS invoices have their service terminated in accordance with the SADIS Agreement. Those who pay for the service should not be expected to pay more to cover the costs of those States who fail to pay.
- 2.2.5 The status of SADIS payment in relation to the 2025 SADIS invoices, as of 10 November 2025, is provided in the Appendix.

3 CONCLUSION

3.1 With regard to the status of payments for the current year (2024 invoices), following review the group may wish to agree that those States who continue to have outstanding payments as at 1200 UTC on 10 February 2026 should have their access to SADIS services (this includes SADIS API) withdrawn without further notice. As such, the group is invited to formulate the following draft conclusion;

Draft Conclusion 26/xx - Scheduled Termination of Access to SADIS for those States that have payments outstanding.

That,

The SADIS Provider be invited to withdraw access to SADIS FTP and SADIS API for those States who, as at 1200 UTC on 10 February 2026, have cumulative outstanding payments over GBP100.00 due for any invoice dated 2025 or earlier.

Note 1: - The SADIS Provider will continue to make all efforts to contact and remind the States of their outstanding payments, but where contact details are no longer valid, a response from the State is not necessary prior to withdrawal of access.
