1. Introduction

1.1 This paper presents the estimated costs of providing the SADIS services in 2012 and the assessments of the States participating in the SADIS Cost Allocation and Recovery (SCAR) Arrangement for the year 2012.

2. Estimated SADIS Costs for the Period 1 January to 31 December 2012

2.1 Table 1 below presents a summary of the estimated SADIS costs for the period 1 January to 31 December 2012. Details of these estimated costs are included in SCRAG/12-WP/10.

3. Cost Shares for the Period 1 January to 31 December 2010

3.1 In accordance with Article XI, paragraph 4 of the SADIS Agreement, any under-recovery of costs for the year 2010 arising from the failure of a Party to pay the SADIS cost share attributable to it for that year shall be added to the total SADIS costs to be shared for the year 2012.

3.2 One State, Maldives, which used to be on the list of Least Developed Countries (LDCs), thus exempt from payment of the SADIS cost share, has recently been removed from that list. Consequently, Maldives is included in the calculation of the assessment of cost shares for 2012.

3.3 Two States, Albania and France, who acceded to the SADIS Agreement in 2011 and receive the SADIS service respectively since 21 August 2011 and 1 October 2011, are included in the calculation of the assessment of cost shares for 2012.

3.4 One State, Australia, that is a user of SADIS FTP data, is included in the calculation of the assessment of cost shares for 2012.

3.5 Two States, Indonesia and Seychelles, that have expressed serious interest in receiving the SADIS service, are included in the calculation of the assessment of cost shares for 2012. Since Indonesia will likely take the service only from 1 March 2012, its share of the assessment of cost shares for 2012 was calculated based on 10 full months of service in 2012.

3.6 Table 2 below presents a summary of the calculation of the amount to be assessed under the SADIS Agreement for 2012.

3.7 The amount to be assessed for 2012 (£803 292) represents the estimated costs for 2012 (£776 751) plus the net under-recovery of 2010 (£26 541). The net under-recovery of 2010 is the amount subject to collection for 2010 (£931 590), less the amounts collected for 2010 (£773 553), less the amounts collected for years prior to 2010 (£1 762), less the adjustment for 2010 (£129 734) calculated in the Attachment to SCRAG/12-WP/7. Since this adjustment for 2010 will be billed separately in 2012 to the States that received the service in 2010, if it is not deducted in the calculation of the net under-recovery of 2010, it would be billed twice which would result in a significant over-recovery in 2012.

3.8 Taking into account the information in Tables 1 and 2 and paragraphs 3.1 to 3.7 above, the Attachment A shows, for the period 1 January to 31 December 2012, the estimated cost share to be borne by each State receiving the SADIS service, based on their 2010 available tonne-kilometres in scheduled services (ATKs), as well as their share of the under-recovery for 2010, in accordance with Article XI, paragraph 4 of the SADIS Agreement. Attachment B shows the amounts to be billed to each State in 2012, corresponding to the adjustment for 2010 (Attachment to SCRAG/12-WP/7) plus the assessment for 2012 (Attachment A), minus the deduction of unused credit balances from previous years.

4. **Action by the Group**

- 4.1 The Group is invited to:
 - a) review the estimated costs of providing the SADIS services for the period 1 January to 31 December 2012 totaling £776 751, presented in Table 1 above;
 - b) note the information presented in paragraphs 3.1 to 3.8 above; and
 - c) determine the assessments for the period 1 January to 31 December 2012 of the States participating in the SCAR scheme in 2012 on the basis of their number of ATKs for 2010, as presented in Attachment A.
