STATUS OF ACCESSION TO THE SADIS AGREEMENT

1. Introduction

- 1.1 ICAO has received a formal notification of accession to the SADIS Agreement from 59 States (Appendix 1). It should be noted that three of these States (Mauritius, Mongolia, Turkmenistan) had the service withdrawn. It should also be noted that three of these States are Least Developed Countries (LDCs), which are exempted from payment of SADIS cost share.
- 1.2 56 other States receiving the SADIS service have not yet formally acceded to the SADIS Agreement (Appendix 2). It should be noted that 29 of these States are Least Developed Countries (LDCs), which are exempted from payment of SADIS cost share.

2. Action by the Group

2.1 The SCRAG Group is invited to note the information presented in paragraph 1 above and in Appendices 1 and 2.
