# 1. Introduction

1.1 This paper presents the estimated costs of providing the SADIS services in 2017 and the assessments of the States participating in the SADIS Cost Allocation and Recovery (SCAR) Arrangement for the year 2017.

# 2. Estimated SADIS Costs for the Period 1 January to 31 December 2017

2.1 Table 1 below presents a summary of the estimated SADIS costs for the period 1 January to 31 December 2017. Details of these estimated costs are included in SCRAG/17-WP/10.

#### 3. Cost Shares for the Period 1 January to 31 December 2015

3.1 In accordance with Article XI, paragraph 4 of the SADIS Agreement, any under-recovery of costs for the year 2015 arising from the failure of a Party to pay the SADIS cost share attributable to it for that year shall be added to the total SADIS costs to be shared for the year 2017. Also, any subsequent remittance is deducted from the total costs to be shared. An over-recovery of costs for 2015 resulted in a decrease in the assessment for 2017.

3.2 Two States, the Democratic People's Republic of Korea and Uzbekistan had their services terminated on 31 July 2016 and were therefore not assessed for 2017. Norway, which has now formally acceded to the SADIS Agreement is included in the calculation of the assessment of cost shares for 2017.

3.3 Table 2 below presents a summary of the calculation of the amount to be assessed under the SADIS Agreement for 2017.

3.4 The amount to be assessed for 2017 (£624 833) represents the estimated costs for 2017 (£639 011) minus the over-recovery of 2015 (£14 178). The over-recovery of 2015 is the amount subject to collection for 2015 (£737 314), less the amounts collected for 2015 (£751 492) and less the amounts collected for years prior to 2015, however no balances were collected for prior years.

#### 4. Working Paper Attachments

#### 4.1 Attachment A – Estimated Cost Shares and Assessments

Attachment A shows, for the period 1 January to 31 December 2017, the estimated cost share to be borne by each State receiving the SADIS service, based on their 2015 available tonne-kilometres in scheduled services (ATKs), decreased by their share of the over-recovery for 2015, in accordance with Article XI, paragraph 4 of the SADIS Agreement.

#### 4.2 Attachment B – Amounts to be Billed

Attachment B shows, for the period 1 January to 31 December 2017, the assessment for each State receiving the SADIS service (Attachment A), decreased by the amount by which the total estimated cost for the year 2015 was above the actual costs for 2015 (Attachment to SCRAG/17-WP/7), in accordance with Article XI, paragraph 3 of the SADIS Agreement. The amount to be billed may also be reduced by unused credit balances from previous years.
